Thank you for your email of 17 September 2021 requesting the following information:

"Since becoming subsumed within DE&S it has become very difficult to obtain information on the running costs and budget of the British Forces Post Office (BFPO). The annual accounts of DE&S make no specific mention of it and makes no reference to the BFPO at all. The last accounts I am able to find within the public domain go back to 2006 - published in 2007 when it is assessed that the BFPOs operating budget was in the region of £34 million and it employed 311 people.

Could you please advise me what the annual operating budget of the BFPO has been over the last 5 years?"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD), and I can confirm that all the information in scope of your request is held.

The information you have requested can be found below.

¹ The Equipment Programme is the expenditure for delivery of BFPO's service i.e. Freight Movement, Sorting System and related IT, Fleet car charges for Defence Couriers etc.

² Operation Expenditure consists of all the support to delivering the service i.e. People Costs, Travel & Subsistence, Professional Fees, Property Maintenance etc.

I can confirm that the BFPO ceased to be an Executive Agency of the MOD on 1 April 2007. when it became part of Defence Equipment and Support (DE&S). Since then the BFPO's accounts have been consolidated within the DE&S Annual Report and Accounts.
