Please say whether the complaint was made by

- a) member of the public
- b) police officer/ member of staff

I would also be grateful if you could indicate the seniority of the staff member. For example if a police officer, are they a sergeant/ chief inspector/ superintendent

- b) women.

Please break this down by year and also by claims made against

- a) police officers and
- b) police staff
- 3 What outcome/decisions were taken as a result of each these complaints/claims. Please break this down by year and by outcome for
- a) police officer and

- 1 Male Police staff, alleged illegal sexual activity with Female Member of public, case is ongoing
- 2 Male Constable, alleged sexual assault/rape on female member of public, Resigned, awaits trial
- 3 Male Police staff, inappropriate sexual Conduct towards female member of public, unsubstantiated, no case to answer
- 4 Male sergeant, alleged inappropriate sharing of images of sexual nature of female member of public, case is ongoing
- 5 Male Constable, sending messages of sexual nature to a female, case is ongoing.

The Civil Nuclear Constabulary is a specialist armed police service dedicated to the civil nuclear industry, with Operational Policing Units based at 10 civil nuclear sites in England and Scotland and over 1600

police officers and staff. The Constabulary headquarters is at Culham in Oxfordshire. The civil nuclear industry forms part of the UK's critical national infrastructure and the role of the Constabulary contribute to the overall framework of national security.

The purpose of the Constabulary is to protect licensed civil nuclear sites and to safeguard nuclear material in transit. The Constabulary works in partnership with the appropriate Home Office Police Force or Police Scotland at each site. Policing services required at each site are greed with nuclear operators in accordance with the Nuclear Industries Security Regulations 2003 and ratified by the UK regulator, the Office for Nuclear Regulation (ONR). Armed policing services are required at most civil nuclear sites in the United Kingdom. The majority of officers in the Constabulary are Authorised Firearms Officers.

The Constabulary is recognised by the National Police Chiefs' Council (NPCC) and the Association of Chief Police Officers in Scotland (ACPOS). Through the National Coordinated Policing Protocol, the Constabulary has established memorandums of understanding with the local police forces at all 10 Operational Policing Units. Mutual support and assistance enable the Constabulary to maintain focus on its core role.

We take our responsibilities under the Freedom of Information Act seriously but, if you feel your request has not been properly handled or you are otherwise dissatisfied with the outcome of your request, you have the right to complain. We will investigate the matter and endeavour to reply within 3 – 6 weeks. You should write in the first instance to:
