## Part II. Certification

I, the undersigned official veterinarian, declare that I have read and understood Regulation (EC) No 1069/2009 of the European Parliament and of the Council and in particular Article 10(b)(iv) thereof, and Commission Regulation (EU) No 142/2011 and in particular Annex XIV, Chapter II thereof, and certify that:

- II.1** the pig bristles described above have been obtained from pigs originating, and slaughtered in a slaughterhouse, in the country of origin;
- II.2** the pigs, from which the pig bristles have been obtained, did not show during inspection, carried out at the time of slaughtering, signs of diseases communicable to humans or animals and were not killed to eradicate any epizootic disease;
- II.3** the country of origin or, in case of regionalisation according to retained EU law, the region of origin, has been free from African swine fever for at least 12 months;
- II.4** the pig bristles are dry and securely enclosed in packaging.

## Notes

References to European Union legislation within this certificate are references to direct EU legislation which has been retained in Great Britain (retained EU law as defined in the European Union (Withdrawal) Act 2018) and can be viewed on the UK legislation website (legislation.gov.uk).

References to Great Britain in this certificate include Channel Islands and Isle of Man.

### Part I:

- Box reference I.6: Person responsible for the consignment in Great Britain: this box is to be filled in only if it is a certificate for transit commodity; it may be filled in if the certificate is for import commodity.
- Box reference I.11 and I.12: Approval number: the registration number of the establishment or plant, which has been issued by the competent authority.
- Box reference I.12: Place of destination: this box is to be filled in only if it is a certificate for transit commodity. The products in transit can only be stored in free zones, free warehouses and custom warehouses.
- Box reference I.15: Registration number (railway wagons or container and lorries), flight number (aircraft) or name (ship); information is to be provided in case of unloading and reloading.
- Box reference I.23: For bulk containers, the container number and the seal number (if applicable) should be included.
- Box reference I.25: Technical use: any use other than for animal consumption.
- Box reference I.26 and I.27: Fill in according to whether it is a transit or an import certificate.
- Box reference I.28: Manufacturing plant: provide the veterinary control number of the registered establishment.

Note for the person responsible for the consignment in Great Britain: this certificate is only for veterinary purposes and has to accompany the consignment until it reaches the border control post.
