# Part II. Certification

#### II.1 Animal health attestation

I, the undersigned official veterinarian responsible for the approved body, institute or centre/holding <sup>(1)</sup> of origin certify that the animals described in Part I meet the following requirements:

- (d) where there have been no clinical or non-clinical cases of tuberculosis and brucellosis for the past 6 months;

#### II.1.9 African swine fever
