I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

In response to your queries, I have completed a search for the information within the Defence Electronics & Components Agency (DECA), and I can confirm that **we do hold information in scope of your request** and I detail the answers below.

The Defence Electronics and Components Agency has footprints across three MOD sites, MOD Sealand, MOD Stafford and MOD Donnington. DECA is the sole custodian for MOD Sealand and lodgers on MOD Stafford and MOD Donnington. Further to your clarification, I provide information about the Facilities Management contract for the Sealand site only.
