Thank you for your email of 2 February 2022 to the Ministry of Defence (MOD) requesting the following information:

*“ The medal entitlement for the following former RAF serviceman:*

[REDACTED]

*Service during the Second World War. Confirmation is medals were not claimed as his daughter wishes to claim them”.*

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence and I can confirm that all the information in scope of your request is held.

I should first explain that according to the F543, RAF airmans' service records, [REDACTED] was a Leading aircraftman (LAC) by the end of the hostilities, and not a Sgt.

The medal entitlement for LAC 1078305 [REDACTED] is as follows:

- Defence Medal
- War Medal 1939-45

There is no evidence of the medals previously being issued.
