Thank you for your emails of 8 February 2022 to the Ministry of Defence (MOD) requesting:

## FOI2022/01656

- "I would like to know:
- 1. The total amount of bonus payments made to Veterans UK Medical Advisors over the last 2 financial years?
- 2. A breakdown of how much each individual Medical Advisor received? (Names redacted for GDPR)
- 3. Which MOD form is used to approve bonus payments for Veterans UK Medical Advisors?
- 4. How many 'Thank you' bonus payments have been paid to Veterans UK Medical Advisors over the last 2 financial years? (broken down by individual).
- 5. How much Veterans UK Medical Advisors are paid? (Most recent pay review)".

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the MOD and I can confirm that some information in scope of your request is held. The recorded data regarding requests one and two can be found below:

To answer your other requests regarding 'bonus payments'

In Year Reward Payments are discussed at a monthly reward panel. Approval is provided online and is agreed at the Top Level Budget (TLB) budgetary level, each TLB will have a different approach to this. However, there is an online nomination form and a copy can be found enclosed along with a copy of the policy statement relating to In Year Rewards.

There were no "Thank You" payments made to Veterans UK Medical Advisors over the last two financial years

Finally, in answer to your last request regarding Veterans UK Medical Advisors salary, the information you have requested falls entirely within the scope of an absolute exemption under Section 21 of the FOIA as it is reasonably accessible by other means. As Section 21 is an absolute exemption, there is no requirement to consider the public interest in making the decision to withhold the information.
