## **PROVISION OF REQUESTED INFORMATION**

Thank you for your request for information about Avian Influenza test results, which APHA received on 27 January 2022. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and the response is detailed below:

"Please provide all test results and their locations for birds submitted as part of the wild bird monitoring scheme for avian influenza within the borough of Sandwell, West Midlands. I include sites owned by Sandwell council, and those privately owned or owned by CRT.

I am aware that the APHA compile an online list, but this does not state the geographic location on a site by site basis, which is what I am asking for, as well as the date of test result and positive AND negative tests for all birds submitted.

To clarify, I am seeking results tested between November 1st 2021- January 20th 2022"

Please see below list of wild birds submitted as part of the wild bird monitoring scheme for Avian Inluenza (AI).

These have been listed by the initial post code reference as a geographic location. APHA cannot comment on the specifics of the exact location as being owned by either Sandwell council, CRT or any other organisations or individuals. The exact location has been exempted from release citing Section 40 of the Freedom of Information Act (FOIA) 2000.

## Section 40

We can confirm that post code data has been supplied using the first letters/digits of the post code as the full post code in some instances would lead to the identification of premises. Section 40(2), read in conjunction with 40(3)(a)(i), of the FOIA provides that

personal data relating to third parties is exempt information if disclosure would breach the Data Protection Act 2018 (DPA).

This information if released still engages the exemption because the personal data relates to others who would, or would likely, be identified or identifiable from that information, irrespective of the publicly known information.

APHA consider that disclosure of this information is likely to breach the first data protection principle in Schedule 1 of the DPA, which relates to the fair and lawful processing of personal data, in two ways. First, disclosure would not constitute 'fair' processing of the personal data, second, disclosure would not satisfy any of the conditions for data processing set out in Schedule 2 to the DPA. Therefore, we have concluded that this information is exempt from disclosure under section 40 of the FOIA
