Please would you let me know if this property, or the development of which the property forms a part, received public funding, and if so what type of public funding?

Response

Neither Confirm nor Deny

Homes England can neither confirm nor deny that we hold the information requested.

On receipt of a valid request for information, section 1(1) of the FOIA obliges a public authority to inform the requestor under section 1(a) if they hold the information requested, and under section 1(b) communicate that information to them.

However, the duty under section(1)(a) does not apply to your request by virtue of sections 40(2) FOIA.

The request refers to a specific address which could identify an individual. The duty to confirm or deny does not arise if to comply with this duty constitutes third party personal data and would breach one or more of the data protection principles (section 40(2)).

You may also complain to the Information Commissioner's Office (ICO) however, the Information Commissioner does usually expect the internal review procedure to be exhausted in the first instance.
