Thank you for your email of 17 January 2022, in which you requested the following information:

"Under the FOI Act, could you please provide details of the number disciplinary offences committed by staff members at ITC Catterick, ATC Pirbright, AFC Harrogate and ATR Winchester between 2019 to date. I would like a breakdown of the offences by name, and whether the soldiers involved were dealt with by summary hearing or court martial."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000. A search for the information has now been completed within the Ministry of Defence, and I can confirm that the information in scope of your request is held and is attached below in Annex A. Due to the small numbers involved, any further breakdown of these figures would be exempt under section 40 (personal information).

Notes:

- Disciplinary cases recorded on JPA with a date of incident between 1 January 2019 and 14 February 2022. This includes non-criminal conduct (disciplinary offences) and criminal conduct offences, as detailed in chapters seven and eight of JSP 830.
- In order to answer this FOI within the cost limit we have made the assumption that individuals with the rank of Private (or equivalent) are recruits/trainees and individuals with the rank of Lance Corporal (or equivalent) and above are staff members. Staff members may include individuals who are not instructors or recruit facing.
- Please note that the figures provided are single Service estimates based on data which is not gathered for statistical purposes or subject to the same level of scrutiny as official statistics produced by Defence Statistics. The figures provided may therefore be subject to data quality issues affecting their accuracy.

Figure 1: Breakdown of the charges dealt with by Summary Hearing or Court Martial (proven/guilty finding)

Offences dealt with at Summary Hearing:

- Using threatening or disrespectful behaviour towards a superior officer
- Disobedience of a lawful command
- Failing to perform a duty /Negligently performing a duty
- Conduct prejudicial to good order and Service discipline
- Unfitness or misconduct through alcohol or drugs
- Ill-treatment of a subordinate

Offences dealt with at Court Martial:

- Rape
- Sexual Assault
- Attempted sexual communication with a child
- Theft

Offences dealt with at either Summary Hearing or Court Martial:

- Common assault/Battery
- Absence without leave
- Contravention of standing orders
