Legal aid

When people go to court or need legal advice they can sometimes get money to help pay for lawyers to give them advice or speak up for them. This is when they do not have enough money to pay for a lawyer themselves.

This is called **legal aid**.

What we check before giving legal aid



We check 2 things before we decide if someone can get legal aid:

1. How much money they have.



2. How likely their case is to be successful.



This way we can make sure the money we have goes to the people who need it most.



How we asked people what we should change

We had lots of meetings with people who are involved in courts and other interested people and organisations.





The changes we think we need

At the moment there are 2 different schemes for 2 different types of court cases. These are **criminal cases** and **civil cases**.



A **Criminal case** is when the police think someone has broken the law and it has been decided to take them to court.



A **Civil case** is usually a legal argument between people or organisations who think the other has done something wrong and is usually asking a court to decide on a payment to make up for it.



They have different legal aid rules. We want to make them more the same. So we want to:

 start with how much people need to live on and how much money they have spare after paying for things they need like rent or mortgage, council tax and childcare



take away the £545 a month limit on housing costs for single people



allow some money for work costs



 include money people are paying towards their debts.



For changes just to the civil legal aid, we want to:

 put up the amount of money people can keep by using figures that show how much it costs to live



 put up how much people can keep in savings



- not include any money people got for:
 - compensation or damages for personal harm



back payments of benefit or child maintenance payments



 not include homes when the case is about them



 not include things that are worth a lot but difficult to get hold of until later when they can be sold



 not include the savings of people who get some benefits and don't own their own home



 check people who get Universal Credit and have more than £500 a month coming in and earn more than £500 a month



- give legal aid without asking how much money people have, to:
 - children under 18



 parents whose children may have their lifesaving treatment stopped



some people who have had a family member die.



For changes just to the criminal legal aid, we want to:

 put up the amount of money people can keep by using figures that show how much it costs to live



 give legal aid to everyone who is on trial at the Crown Court



 put up the time people pay for to 18 months




 check the savings of people on benefits if they own a home and are found guilty at the Crown Court.



What happens next?

After we have thought about what everyone tells us we will say what we think the new rules should be.



We will then work on changing the law to make them happen.
