HUMBLE ADDRESS: HOUSE OF LORDS APPOINTMENTS

That, given the concerns raised about the appropriateness of, and process for, appointing Lord Lebedev as a member of the House of Lords and the role of the Prime Minister in that process, an humble Address be presented to Her Majesty that she will be graciously pleased to give directions that there be laid before this House, no later than 28 April,

- (a) any document held by the Cabinet Office or the Prime Minister's Office containing or relating to advice from, or provided to, the House of Lords Appointments Commission concerning the appointment of Evgeny Alexandrovich Lebedev as a Member of the House of Lords; and
- (b) the minutes of, submissions relevant to and electronic communications relating to, any meeting within the Cabinet Office or the Prime Minister's Office at which the appointment of Lord Lebedev, or advice relating to that appointment, was discussed in a form which may contain redactions, but such redactions shall be solely for the purposes of national security.

The Minister for the Cabinet Office has laid in Parliament a response to the Humble Address motion of the House of Commons passed on 29 March 2022 and has made a Written Ministerial Statement outlining the considerations the Government gave to the information released.

Evgeny Lebedev is the owner of Lebedev Holdings which owns the Evening Standard, The Independent, two publications unlikely to have survived without his investment, as well as the TV channel London Live. Through his newspapers he has spearheaded a number of campaigns, including the Evening Standard's Dispossessed Fund which has raised over £13m to help address poverty in London and of which he is a patron, and the #AIDSFree campaign which raised over £3m for the Elton John AIDS Foundation. He is also patron of Space for Giants, an international conservation charity and was instrumental in launching the Giants Club initiative which unites leaders of African States and heads of businesses to save Africa's remaining elephant population.
