This introductory note does not form a part of the notice

The following notice gives notice of the variation and surrender in part of an environmental permit.

This variation and partial surrender authorises the following changes:

- Surrender of Tamarisk Farm and associated permitted 32,182 broiler breeder laying hens, which has never been built and stocked.
- Variation to increase livestock numbers at Tagon Harbour Farm from 51,000 to 55,000 broiler breeder laying hens.
- Overall reduction in livestock from 83,182 to 55,000 broiler breeder laying hens.
- Change of installation name from Tagon Harbour Farm and Tamarisk Farm to Tagon Harbour Farm.

Any changes made as a result of the variation and partial surrender are set out in the schedules.

We consider that in reaching our decision to vary the permit we have taken into account all relevant considerations and legal requirements. We are satisfied that the permit will ensure that a high level of protection is provided for the environment and human health and that the activities will not give rise to any significant pollution of the environment or harm to human health.
