A. Brief summary of the case

EXAMPLE

Our client is the father of the child, Anita, and respondent to a care order issued by Anytown District Council. Our client has historic drug and alcohol problems and is facing allegations of causing non-accidental injury to the child. Our client contests that he was not caring for his daughter at the time the injury was sustained and claims that the injury occurred whilst in the care of the mother and maternal grandparents. Our client has also been undergoing drug and alcohol rehabilitation during the proceedings. During the course of the case, X, Y and Z happened.... Etc, etc..... The matter was listed for a 5 day Finding of Fact which concluded after 4 days and a 12 day final hearing is now taking place in July 2019.
