Background

Currently WP post payment validation activity includes matching samples against HMRC data, this automated process is checking for tax records against the individuals for the required period. Following the introduction of the Real Time Information system (RTI) Work Programme samples will now be matched against RTI data. Please note, that due to system availability it has been necessary to amend the sampling timetable.

Summary and action

From June 2016 (May 2016 transaction data) Work Programme will be sampled on the 15th working day of the month. It has therefore been necessary to move NEA sampling from the 15th working day to the 1st working day of the month.

Providers are asked to take note of the revised timetable <u>included at annex 1</u> and ensure any reversal activity is kept within the specified timescales.

Annex 1 DWP Sampling Timeframe

Providers are expected to ensure that all outcomes are checked prior to claim and that all claims must be valid at the point of submission for payment. Once claimed, DWP will extract a sample of cases for validation.

The table below outlines the DWP sampling timeframe for drawing the samples used for validation and then extrapolation.

Programmes	Sample is drawn	We therefore don't expect claims to be backed out from:
New Enterprise Allowance (NEA)	Samples drawn from the 1 st working day of the month	the last working day of the previous month
Community Work Programme (CWP)	Sample drawn from the 6 th working day of the month	the 5 th working day of the month
Work Choice* (WC),	Sample drawn from the 11 th working day of the month	the 10 th working day of the month
Work Programme (WP)	Sample drawn from the 16 th working day of the month	the 15 th working day of the month

For example, using May and June 2016

May 2016

- 1. **For WP** the sample will be taken from Tue 3rd May
- 2. **For CWP** the sample will be taken from Tue 10th May
- 3. **For WC** the sample will be taken from Tue 17th May
- 4. **For NEA** the sample will be taken from Tue 24th May

June 2016

- 1. For NEA the sample will be taken from Tue 1st June
- 2. **For CWP** the sample will be taken from Tue 7th June
- 3. **For WC** the sample will be taken from Tue 14th June
- 4. **For WP** the sample will be taken from Tue 21st June

Once the sample is drawn, the Department would not normally expect a request to back out the claim as the error will be dealt with through the extrapolation of the error rate found from checking the validation sample.
