HIGH SPEED RAIL (LONDON - WEST MIDLANDS) GENERAL VESTING DECLARATION No. 776

This **GENERAL VESTING DECLARATION** is executed on 02ND FEBRUARY 2022 by the Secretary of State for Transport ("the Authority").

WHEREAS:

- (1) On 23 February 2017 the High Speed Rail (London - West Midlands) Act 2017 ("the High Speed Rail Act") received Royal Assent authorising the Authority to acquire the land specified in the Schedule hereto.
- (2) Section 4(1) of the High Speed Rail Act authorises the Authority to acquire compulsorily so much of the land within the limits of the High Speed Rail Act as may be required for Phase One purposes¹.
- (3) Section 8 of the High Speed Rail Act provides that the power under section 4(1) in relation to land may be exercised in relation to the subsoil or under-surface of the land only.
- (4) Section 4(4) of the High Speed Rail Act provides that the Compulsory Purchase (Vesting Declarations) Act 1981 ("the 1981 Act") applies as if the High Speed Rail Act were a compulsory purchase order and paragraph 3² of Schedule 6 to the High Speed Rail Act provides that the 1981 Act shall have effect subject to the modifications specified in that paragraph.
- (5) Notice pursuant to section 3A³ of the 1981 Act was first published on 21 September 2021. That notice included the particulars specified in section 3A(3) of the 1981 Act.

NOW THIS DEED WITNESSETH that, in exercise of the powers conferred on it by section 4 of the 1981 Act, the Authority hereby declares:-

1. The land described in the Schedule hereto (being part of the land authorised to be acquired by the High Speed Rail Act) and more particularly delineated and shown coloured yellow on the plan annexed hereto, together with the right to enter upon and take possession of the land, shall vest in the Authority as from the end of the period of 3 months from the date on which the service of notices required by section 6⁴ of the 1981 Act is completed.
2. For the purposes of Section 2(2) of the 1981 Act, the specified period in relation to the land comprised in this declaration is one year and one day.

07729	All that stratum of subsoil that lies beneath 4440.63 square metres, or thereabouts, of railway station, platform, premises (South Hampstead Station), railways (Watford DC line and West Coast Main line), works, land and bridge carrying railway (Chiltern Main line) above, the upper extremity of which is 5.5 metres above Ordnance Survey Datum and the lower extremity of which is 13.2 metres below Ordnance Survey Datum.
07732	All that stratum of subsoil that lies beneath 53.71 square metres, or thereabouts, of railway platform (South Hampstead Station), railway works (Watford DC lines) and land, the upper extremity of which is 5.3 metres above Ordnance Survey Datum and the lower extremity of which is 13.0 metres below Ordnance Survey Datum, excluding any interests held by the Secretary of State for Transport.
07733	All that stratum of subsoil that lies beneath 242.86 square metres, or thereabouts, of gardens (6-10 (even), Hilgrove Road), the upper extremity of which is 5.4 metres above Ordnance Survey Datum and the lower extremity of which is 13.0 metres below Ordnance Survey Datum, excluding any interests held by the Secretary of State for Transport.
07743	All that stratum of subsoil that lies beneath 681.70 square metres, or thereabouts, of public road, footways, footpath (Hilgrove Road, B509) and tunnels carrying railway (Watford DC lines), works and land (Primrose Tunnels) below, the upper extremity of which is 5.6 metres above Ordnance Survey Datum and the lower extremity of which is 12.8 metres below Ordnance Survey Datum, excluding any interests held by the Secretary of State for Transport.

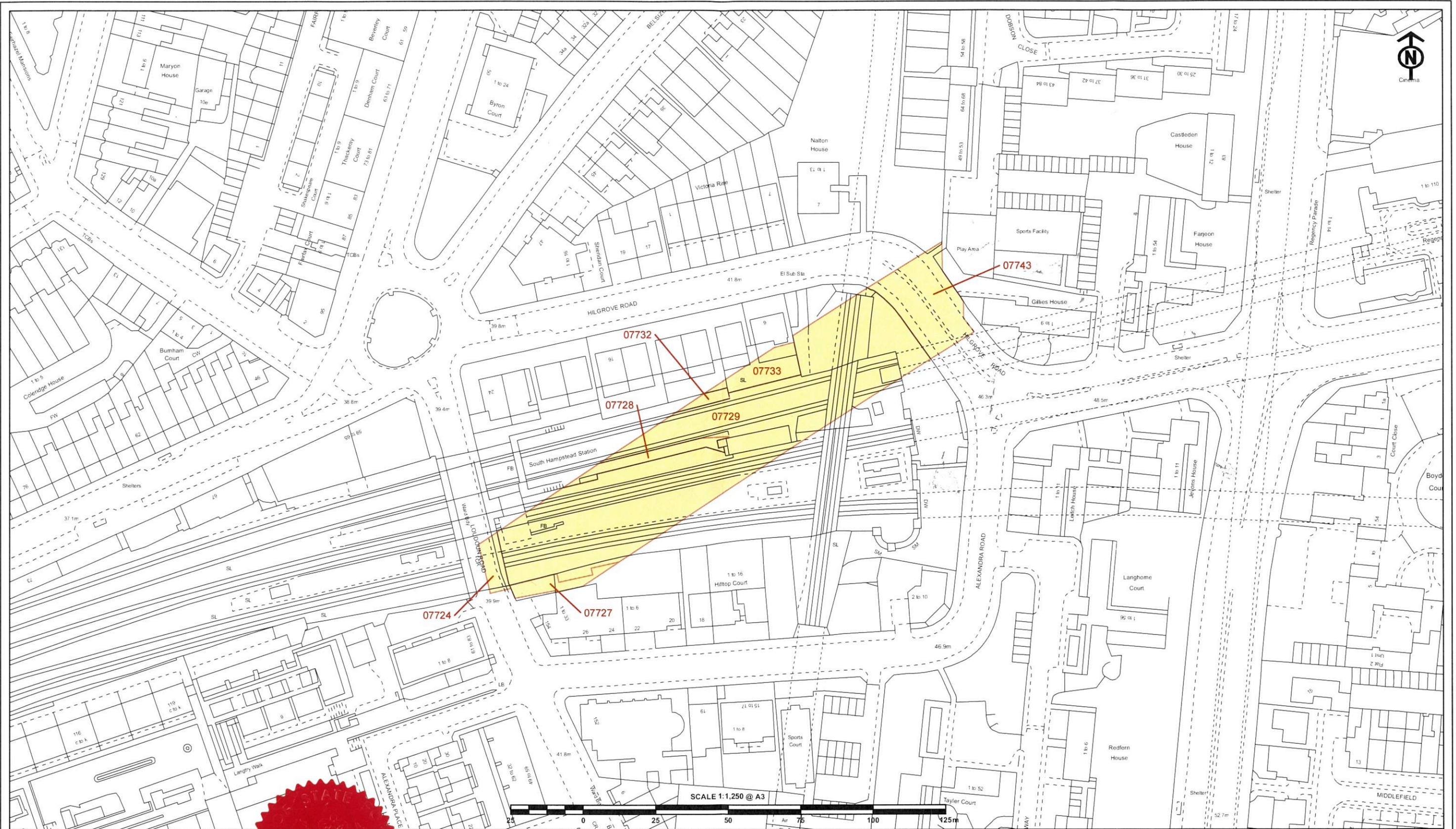
