## JUDGMENT

The complaint of **Unfair Dismissal** is struck out.

## REASONS

1. Upon receiving the ET1 claim form on the 15 September 2021 the claim of unfair dismissal has been struck out due to the reasons set out below;
  - The claimant did not have the qualifying two years' service under section 108 of the Employment Rights Act 1996 or any exceptional circumstances that provide for an exemption to the qualifying service period.
1. The claimant has failed to make representations in writing, or has failed to make any sufficient representations, why this should not be done or to request a hearing. The complaint of **Unfair Dismissal** is therefore struck out.
2. This judgement applies to all other claimants that are party to this claim as set out below.
3. The claimant's and all other claimants remaining claims continue.
