Thank you for your email of 20 April 2022 to the Ministry of Defence (MOD), seeking the policy for the War Pension Unemployability Supplement (UNSUPP). You asked for the following information:

"Under the freedom information and access to information I request a copy of the Unemployablilty Supplements Policy Time and dated to my awards of said and any lawful changes made."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and I can confirm that all the information in scope of your request is held. However, the information you have requested falls entirely within the scope of an absolute exemption under Section 21 of the FOIA as it is reasonably accessible by other means. As Section 21 is an absolute exemption, there is no requirement to consider the public interest in making the decision to withhold the information.
