PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about welfare statisites, which APHA received on 16 February 2022. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and the response is detailed below:

"could you confirm whether animal welfare inspection reports of farms, abattoirs, pet breeding facilities, fish farms and laboratories are published for the general public to view?"

APHA can confirm that these reports are not published.

"If not can you confirm if a FOI request would enable me to view summarised data for all inspections and their conclusion, actions required. A sample size of approx five years for England or United Kingdom if not devolved, would be ideal.

I wish to establish

- -number of inspections carried out per annum for each of the categories for last five years.
- -of those inspections what percentage were as a result of a third party informant advising Defra of alleged animal welfare issues.
- -number of places per category that had no issues, required intervention or were closed
- or whatever grading system defra use.
- -number of those businesses within those categories per annum to establish growing trend or declining trend in those types of business and to compare inspection numbers.
- -List of top 100 businesses per category where Defra have serious concerns regarding animal welfare and have instructed the owners to improve.

The information you have requested can be found attached at Appendix 1.

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.

Some of the information has been exempted from release citing Section 40 of the Freedom of Information Act (FOIA) 2000.

Section 40

Some of the information (list of top 100 businesses) requested has been withheld under section 40(2), read in conjunction with 40(3A)(a), (third party personal data), of the FOIA as the information constitutes personal data relating to a third party. Section 40(2), read in conjunction with 40(3A)(a), of the FOIA provides that personal data relating to third parties is exempt information if disclosure of that information would breach any of the data protection principles in Article 5(1) of the General Data Protection Regulation (GDPR).

APHA consider that disclosure of this information is likely to breach the first data protection principle in Article 5(1)(a) repeated in 35(1) DPA, which provides that personal data must be processed lawfully, fairly, and in a transparent manner in two ways. First, disclosure would not constitute 'fair' processing of the personal data, second, disclosure of that information would not be 'lawful'.

APHA have concluded that this information is exempt from disclosure under section 40 of the FOIA.

Information disclosed in response to this FOI request is releasable to the public. In keeping with the spirit and effect of the FOI and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context. No information identifying you will be placed on the GOV.UK website.

An Annex is attached which explains the copyright that applies to the information being released to you and contact details should you be unhappy with the service you have received.
