

'Consider Additional Factors' Appeal Form and Guidance

Version 1, June 2022

Please read these instructions carefully. You will need to provide all the information we ask for. If you do not provide all the information we need, we will refuse your appeal.

We need you to provide:

- 1. A personal statement.
- 2. Character references.

You may also provide evidence of your rehabilitation since your offence(s).

We explain what we need in more detail below.

You may be appealing against our intention to do either or both of the following:

- refuse your application for a licence
- revoke a licence you already hold

If you are appealing against both of the above then you only need to write one personal statement and provide one set of character references. We will take them into account for both appeals.

Personal statement

Your personal statement must refer to the offence(s) we listed in the letter we sent you when we informed you of our intention to refuse your application / revoke your licence. It should include any details that you feel may affect our decision.

Points you may wish to consider are:

- what are your feelings now about the offence(s) you committed?
- how have you changed since then?
- did any other factors contribute to your actions?
- why do you believe that you are fit to hold an SIA licence?

Do not use your personal statement to argue against the details of your criminal record. You may feel that you were treated unfairly or given a harsh sentence, but we will not be able to take this into account. We can only consider your criminal record as presented on your criminality disclosure.

You can give us your personal statement through your SIA online account. You can do this by going to the 'Make an appeal' page and:

- entering your personal statement into the 'Appeal text' box, or
- uploading your personal statement as an attachment.

Character references

You can provide as many character references as you wish. However, we are interested in the content and quality of the references you provide, not the number.

We can ask you to provide additional character references if we need to. We will do this if the character references you initially provide:

- do not meet our criteria (as explained in Get Licensed and this document)
- are insufficient, considering the seriousness of your offence(s)

We recommend that all your referees use the form we have provided below, as it asks for the information we need. You should print a separate copy of the form for each character reference.

If your referees do not use this form, you must make sure that their reference includes all the information we ask for.

Anyone providing a character reference for you must know about the offence(s) we listed in our letter. We will ask them about this in the form.

We prefer references that are not from:

- your friends
- members of your family (this includes people that are related to you by marriage)
- your current/future employer in the private security industry

This is because they will have personal or business reasons for wanting you to have a licence.

We may contact the person providing the reference. If we cannot contact your referee, we may ask you to provide another one. If you do not, then we may reject your appeal and refuse your application / revoke your licence.

We may also call you to confirm the details in the reference.

Please make sure that the references you send us are completed only by your referees. You must not edit them in any way. If you do, you will be committing a criminal offence.

Evidence of your rehabilitation

You may show us evidence of your rehabilitation since your offence(s). Examples of what we mean by "evidence of rehabilitation" are:

- proof that you have undertaken voluntary training in relation to your offence(s).
- proof that you have taken part in other community activities.

Character Reference

This form should be completed by the person providing the reference, NOT the licence applicant/licence holder.

The person who asked you to complete this form has applied for a licence from the Security Industry Authority (SIA) or already holds a licence that we are proposing to revoke.

We will use your character reference to help us decide whether they are suitable to work in a position of trust. It is important that you answer all the questions accurately and provide as much information as possible. We may contact you to confirm the information you provide.

- You should give your occupation as 'unemployed' if you are not currently employed.
