Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

You requested the following information:

RE Brent House 349-357 High Road, Wembley, HA9 6BZ

The above development was developed by Genesis Housing Association, now called Notting Hill Genesis following a merger with Notting Hill Housing Trust.

The development comprises of 248 units. I would be grateful if you could send me details of how much grant was paid to Genesis for the above development split across the tenure types and also for the number of units covered by grant.

Response

We can confirm that Homes England does not hold the information detailed in your request.

To conclude that the information is not held, we have searched with our Affordable Housing Grants team who would have the requested information if held.
