We refer to your email dated 18 August 2021 to the Ministry of Defence Police which was acknowledged on the same date.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

The information I am requesting -

- 1. How many officers of the rank Pc and Sergeant are currently unarmed and have been for more than 6 months and those who have been for 12 or more months?
- 2. How many are on permanent agreements to be reviewed?
- 3. How many of all ranks of officers unable to attain 7.6 on the MSFT by rank?
- 4. How many Police Officers are being used to carry out jobs relating to the GRS system along with all of those still being used to run other rosters?

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.
