I am treating your correspondence as a request for information under the Freedom of Information Act 2000.

I can advise following a search of its records MOD holds some of the information you have requested. Staff absence because of COVID-19 are captured as part of routine manual returns to the centre; however, because the information is supplied to the centre as an aggregate return, additional information on the demographic profile (sex, ethnicity, disability, sexual orientation, age or religion) of the staff affected is not available.

Under section 16 of the Act (Advice and Assistance) you may find it useful to note:

Defence Statistics Health collate COVID-19 absence returns from individual Top-Level Budget's (TLBs). In accordance with the Defence Advice Notice (DAN) #12, the MOD require TLBs and all defence enabling organisations to report the number of COVID-19 related absences as of Thursday each week.

Thus, it is not possible to provide the total number of personnel in the department who have been absent due to COVID-19 as the MOD only collects a snapshot of data each week.

Individuals may appear in consecutive weeks or, be absent any day from Friday to Wednesday in a reporting week and return to work on a Thursday and will not be counted in the regular return. The TLB data relies on Defence personnel informing their line management chain that they have had a COVID-19 related absence. Please note that personnel may have had symptoms and/or a positive test and still have been able to work from home, these cases will not be included in the numbers provided in this answer as the data relates to COVID-related absences only.
