Thank you for your emails of 13 December 2021 and 14 December 2021 requesting the following information:

"Could the following additional information in total be requested:

- 1. Could you confirm of these poeple how.many or MLD / MFD?
- 2. Which if any have a recommendation for an Epi Pen?
- 3. Which if any have a Brazil Nut Allergy"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000. A search for the information has now been completed within the Ministry of Defence and I can confirm that information in scope of your request is held. However, I must advise you that we will not be able to answer your request without exceeding the appropriate cost limit. As no read code exists that identifies a brazil nut allergy specifically, this would require a clinician to read each of the medical records of Service personnel with a nut allergy to determine if there were any textual notes specifying a brazil nut allergy. This would take in excess of **one week** of effort.

Section 12 of the Act makes provision for public authorities to refuse requests for information where the cost of dealing with them would exceed the appropriate limit, which for central government is set at £600. This represents the estimated cost of one person spending 3.5 working days in determining whether the department holds the information, and locating, retrieving and extracting it.

The MOD may be able to provide some information in scope of your request if you reduce or refine your request to bring the cost of compliance under the limit.

Under Section 16 (Advice and Assistance) you may find it helpful to note MOD may consider providing the following information which is in scope:

Of the UK armed forces personnel serving as at 1 October 2021 who have had a diagnostic read code for a nut allergy entered into their electronic health record;

- a) how many were graded with a Medical Deployability Standard of MLD/MFD (as at 1 October 2021)
- b) how many had been prescribed an epinephrine autoinjector (Epi Pen) in the last 18 months (as at 1 October 2021)
