Summary:

To ensure continuity in supply, Fresenius Kabi Limited has obtained approval from the Medicines and Healthcare products Regulatory Agency (MHRA) to supply the above referenced product from the Irish market which is expected to be on the UK market from April to June 2022. These packs are labelled Folinic acid (as calcium folinate) 10 mg/ml solution for injection or infusion, the batch numbers, expiry dates and batch size concerned are noted in the table at the top of this letter.

- This product is considered licensed in the UK

- Please ensure the <u>UK Summary of Product Characteristics</u> (SPC) and <u>Patient Information Leaflet</u> (PIL) are followed.




