Thank you for your emails of 19 October 2021 and 14 December 2021 to the Ministry of Defence (MOD), seeking information about Medical Advisors

You requested the following information:

"I have a generic policy query regarding War Pension and AFCS Medical Advisors, are they required to sign any files they submit back to claimants if there is a box provided and if it states NAME are they also required to print their name? If any documents are not signed are they still viable documents in the remit of Veterans UK?

14 December 2021 - what the internal policy is regarding Medical Advisors signing and printing names on Claimant's case files".

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

## Background

The decision-making process for both AFCS and WPS requires authentication from the caseworker on behalf of the Secretary of State and from the Medical Advisor (MA) where any medical certification or advice is provided.

The Tribunal have observed that there are occasions where the MA has either not signed or initialled their contribution to the decision.

OPPT Directive 22/2019 instructs what details should be redacted and this must be adhered to. There are a number of completed appeals waiting to be listed that may have unsigned documents which need action before proceeding to hearing.

#### Action for England and Wales

# This directive must be read in conjunction with OPPT Directive 09/2021, Paper Hearings in England and Wales.

In addition to indicating Veterans UK's preference on the type of appeal on form AFCSWPS1648, the name of the MA needs to be confirmed for each piece of advice where a signature or initials do not appear.

You will need to check through the response and record those MA certificates or entries and indicate which MA provided that advice (example below):
