Thank you for your email dated 27 January 2022 requesting the following information:

...We are not seeking individual details, merely a summary of the number of Muslim personnel who have died in service from Palestine 1945-1948 to the present day

I am treating your correspondence as a request for information under the Freedom of Information Act 2000. A search for the information has now been completed within the Ministry of Defence, and I can confirm that information in scope of your request is held.

From 1 August 1945 to 31 December 2021 (the latest data available), there were **45** deaths among UK armed forces personnel where their religion was recorded as either Muslim or Mohammedan on the Armed Forces Memorial database.

Under section 16 of the Act (Advice and Assistance), you may find it useful to note the following:

From 1 August 1945 to 31 December 2021 (the latest data available), there were **6,770** deaths among UK armed forces personnel for whom no religion was recorded electronically. Personnel files held at the MoD central records facility or the National Archive may hold further information on religion but the person hours required to manually search and retrieve this information would exceed the appropriate cost limit for a Freedom of Information request.

Section 12 of the Act makes provision for public authorities to refuse requests for information where the cost of dealing with them would exceed the appropriate limit, which for central government is set at £600. This represents the estimated cost of one person spending 3.5 working days in determining whether the department holds the information, and locating, retrieving and extracting it.

Defence Statistics Health compiles the Department's authoritative deaths database for all UK Armed Forces personnel who died whilst in Service since 1984. Information is compiled from several internal and external sources from which we release several internal analyses and external National Statistics Notices.

For data prior to 1984, Defence Statistics have access to the Armed Forces Memorial (AFM) database owned by the tri-Service Joint Casualty and Compassionate Centre. The AFM database was created to identify Service personnel whose names were and continue to be engraved on the Armed Forces Memorial at the National Arboretum in Staffordshire. The AFM database records the deaths of all personnel who have died in Service since 1st Jan 1948, and for those who were killed or who died in Palestine from 1st Aug 1945 to 31st Aug 1948. Please note, the AFM database is not regarded as a validated source of historical fatality information, therefore, it cannot be guaranteed to be 100% complete or accurate due to it being populated manually from Service files.

The AFM roll of honour can be accessed at <https://www.gov.uk/search-armed-forces-memorial-roll-of-honour>. Entries on the roll of honour database include rank, type of service, regiment or corps, date of death, burial place (if known) and whether someone's name is on the Memorial in the National Memorial Arboretum.
