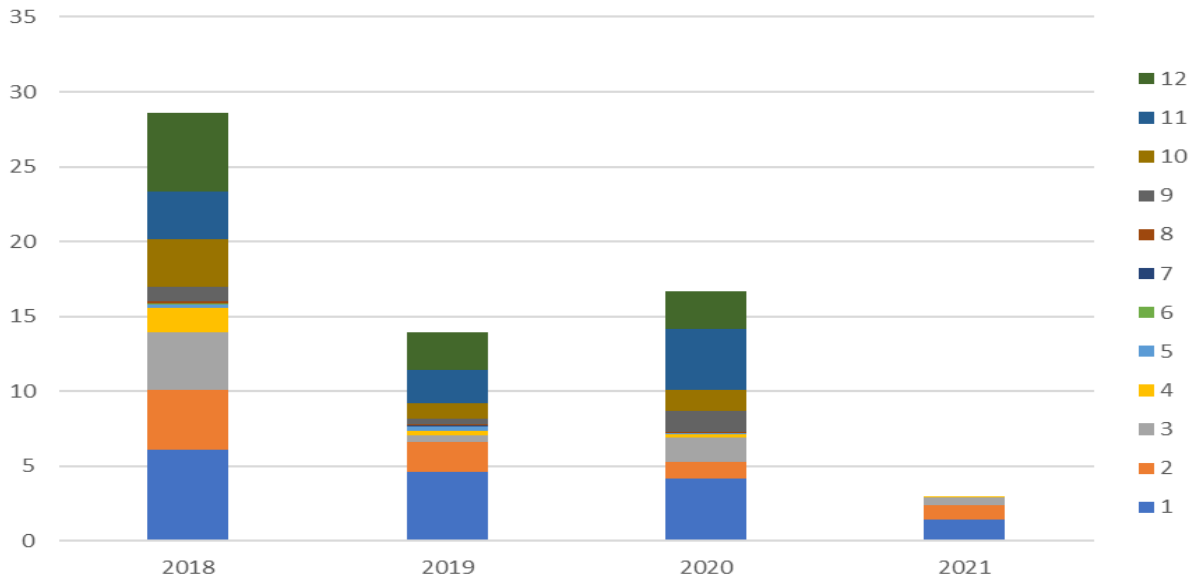

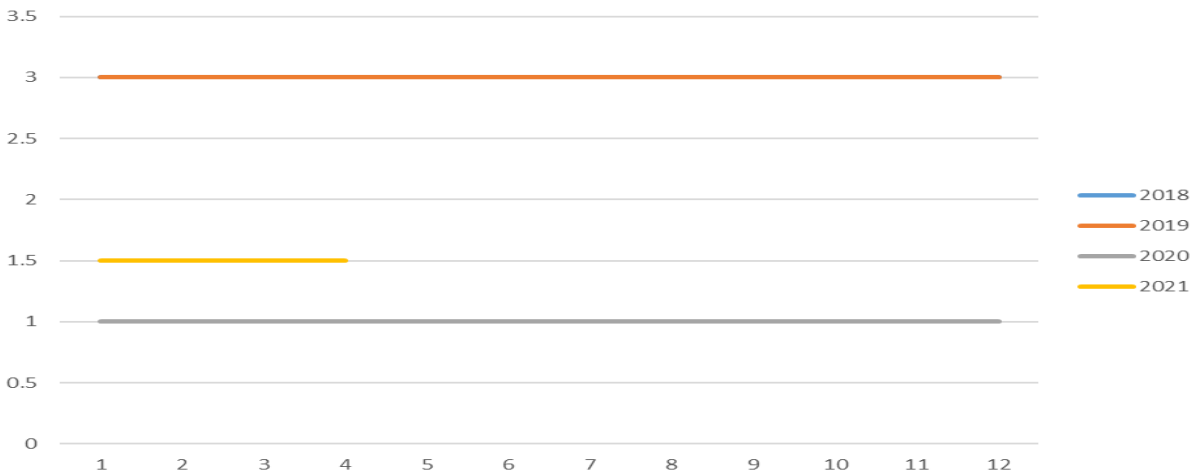


NS Cod – Under 10s

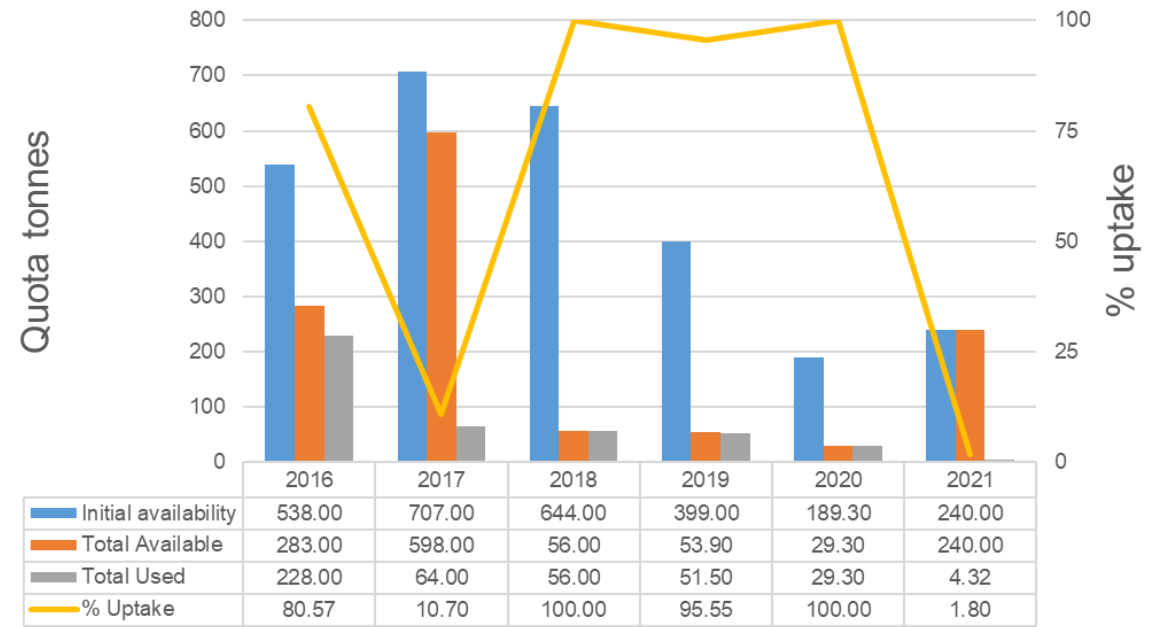
U10m-CODNS -Monthly Uptake by Year

Cod - North Sea - Under 10 - Available quota and total uptake



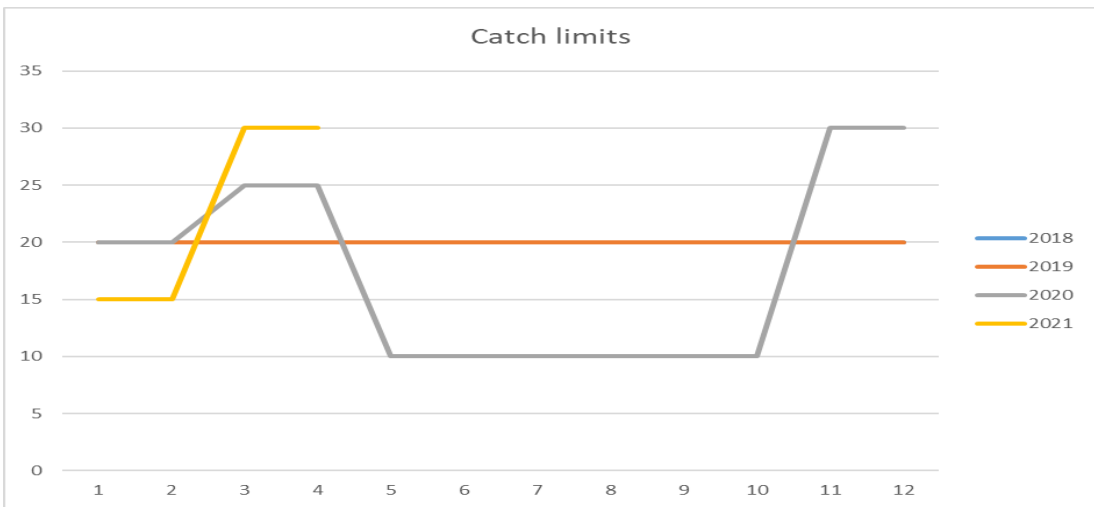
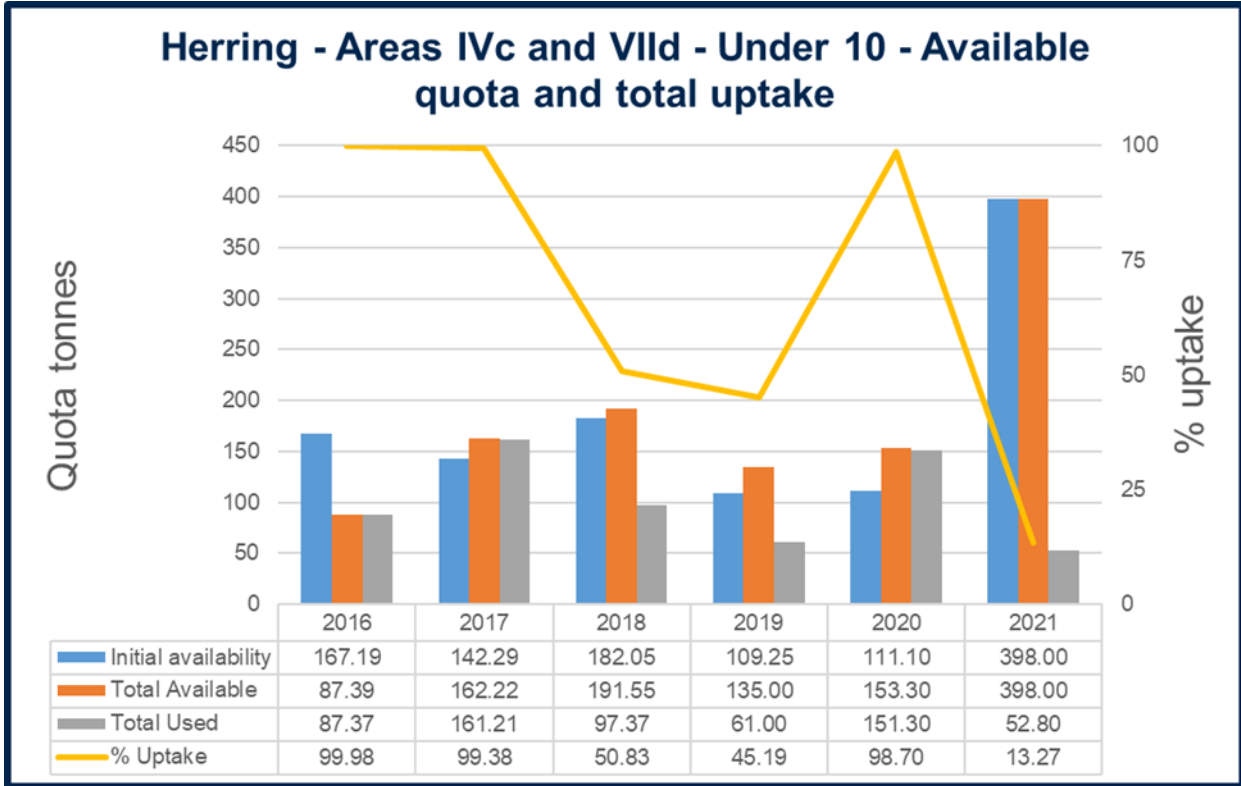
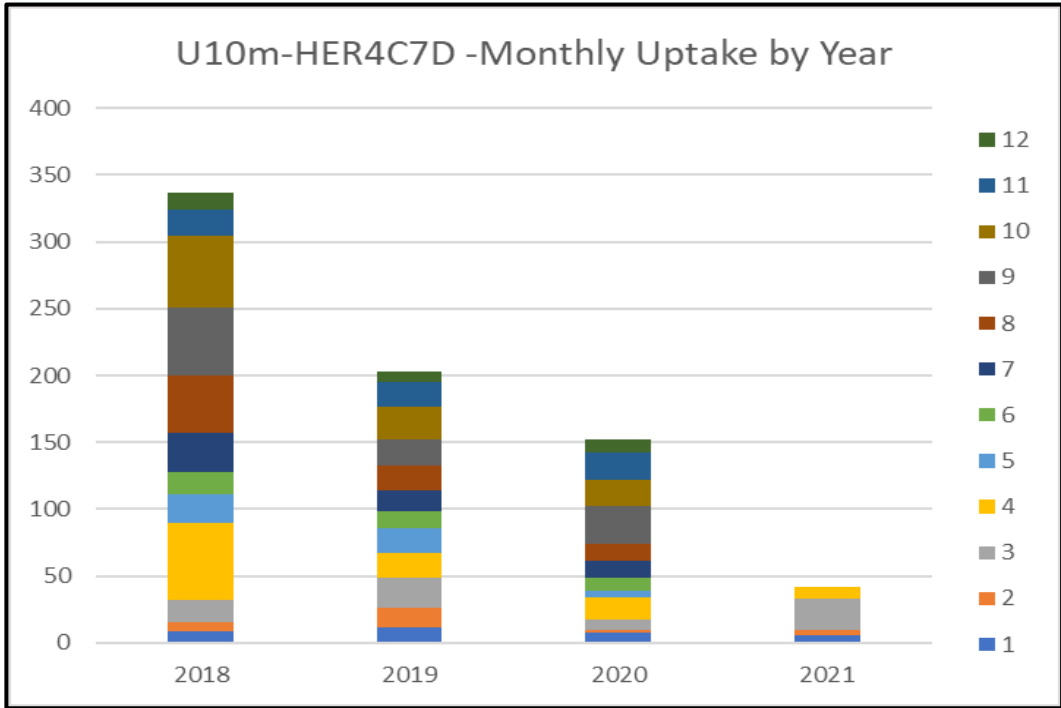
Catch limit – 1.5t

Herring IVc & VIId– Under 10s



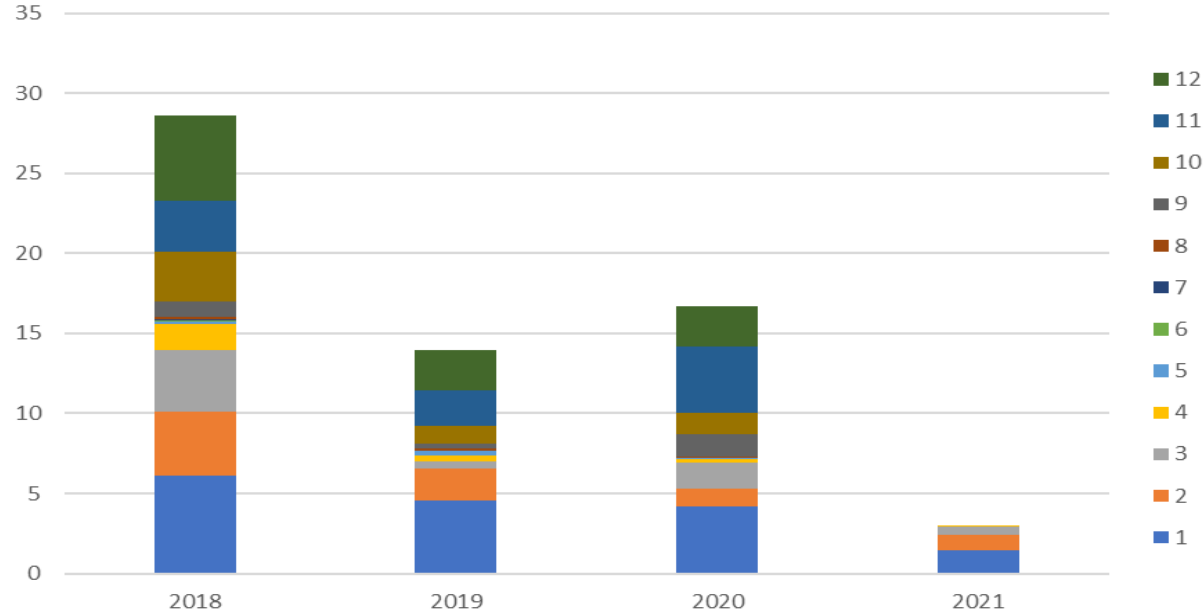
Catch limit – 30t

O10 have 100t available quota

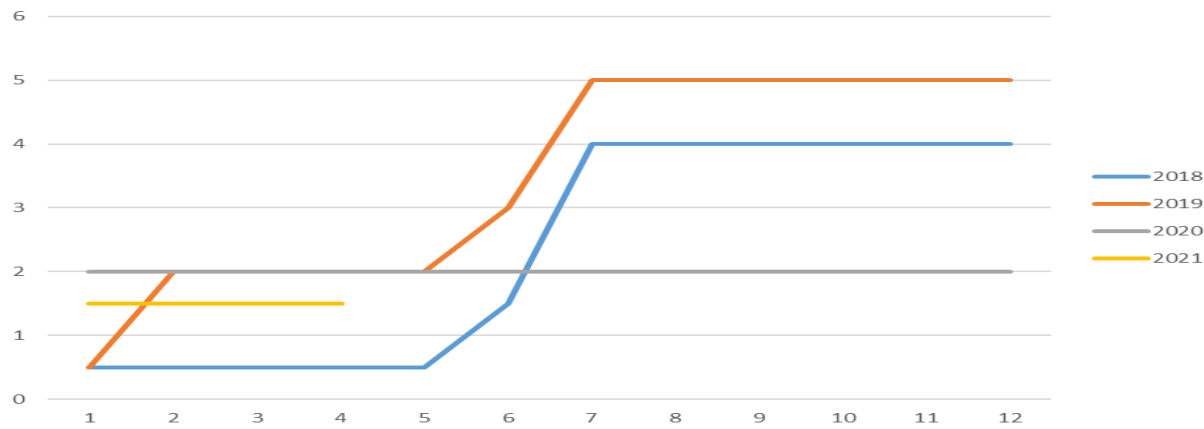

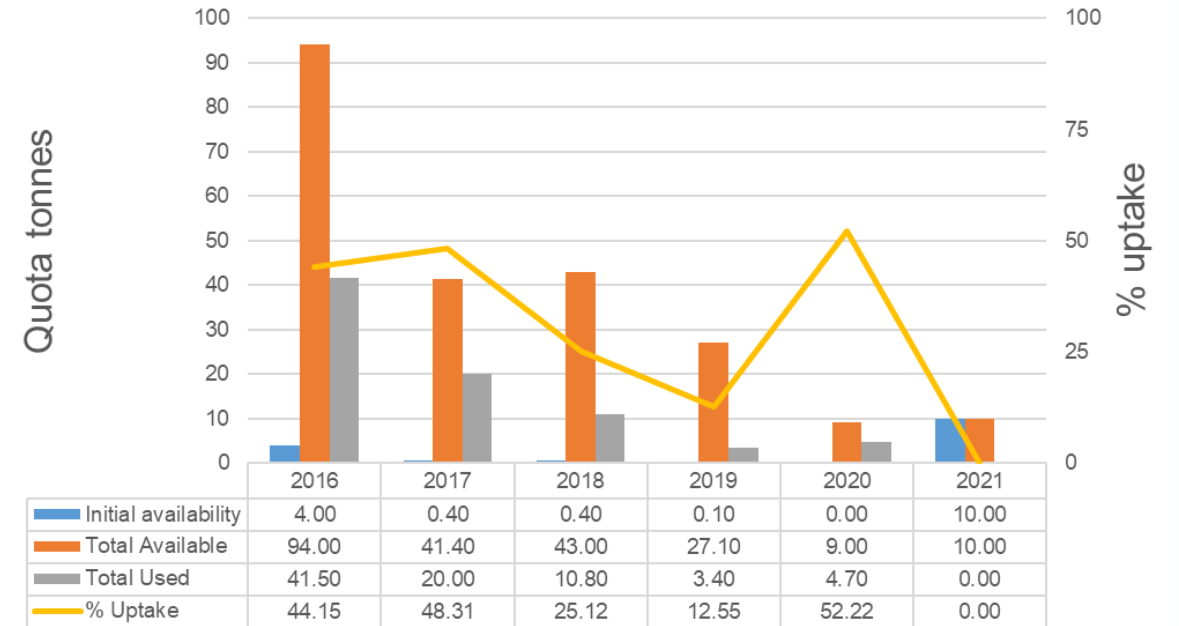
U10m-MACNS -Monthly Uptake by Year

Mackerel - North Sea - Under 10 - Available quota and total uptake

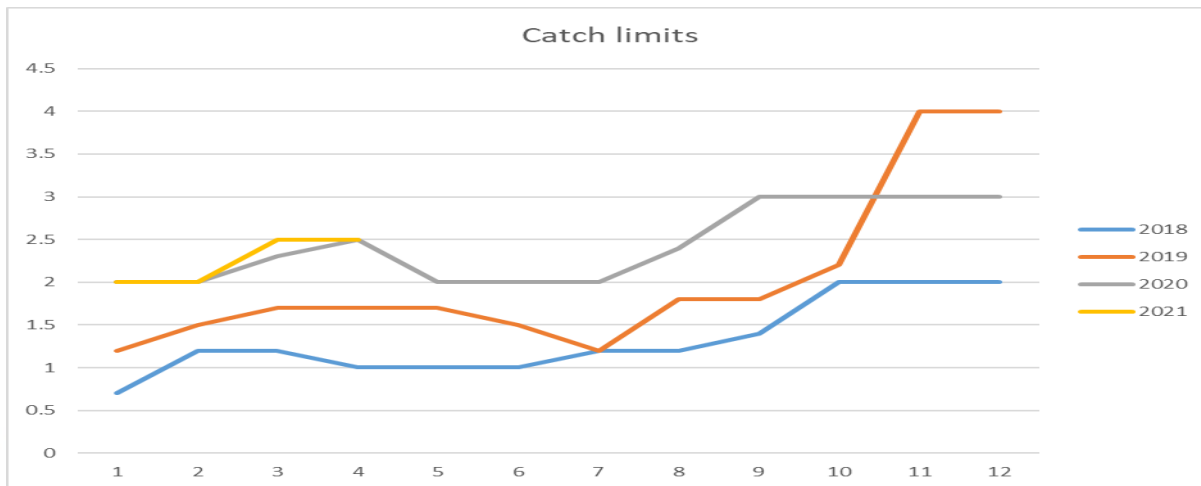
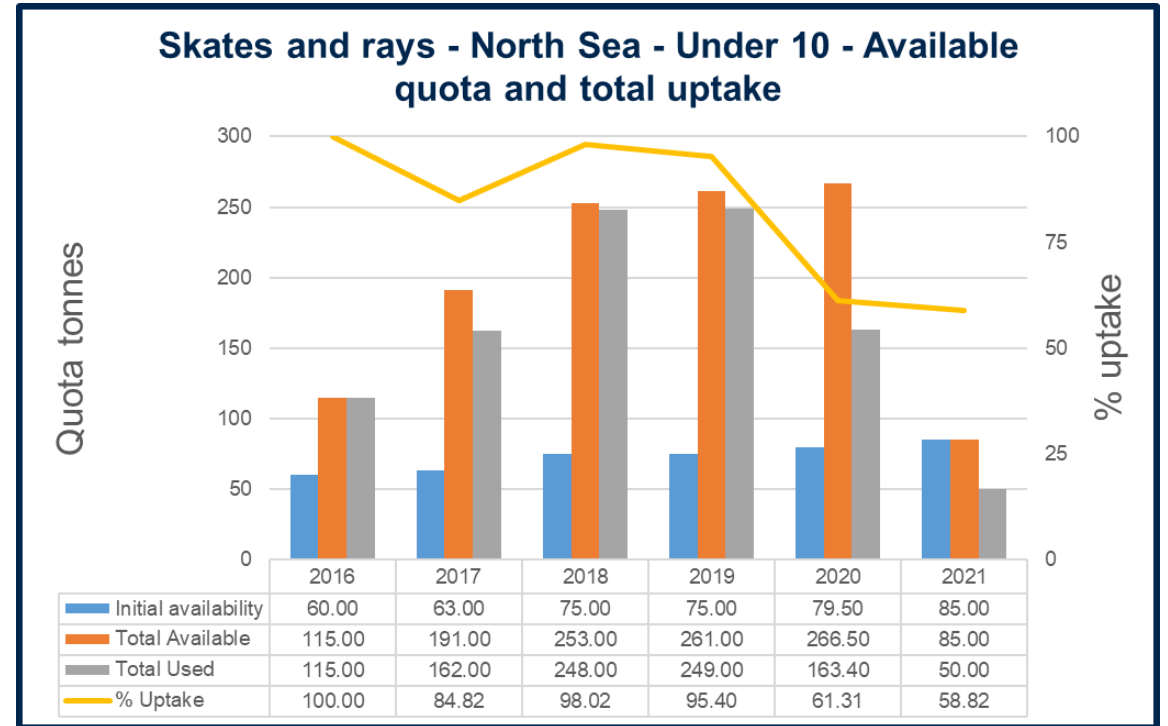
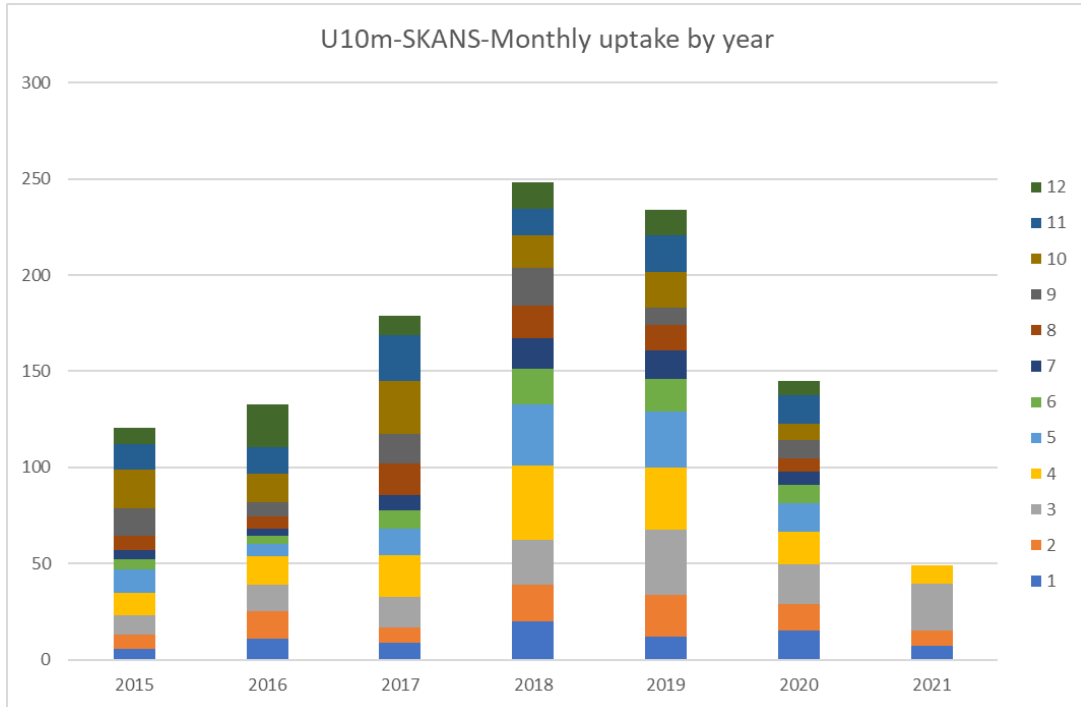


Initial allocation of 10t (this is the first time we have had an initial allocation since 2016).

Catch limit 1.5t. We have had requests for an increase to 5t if possible.

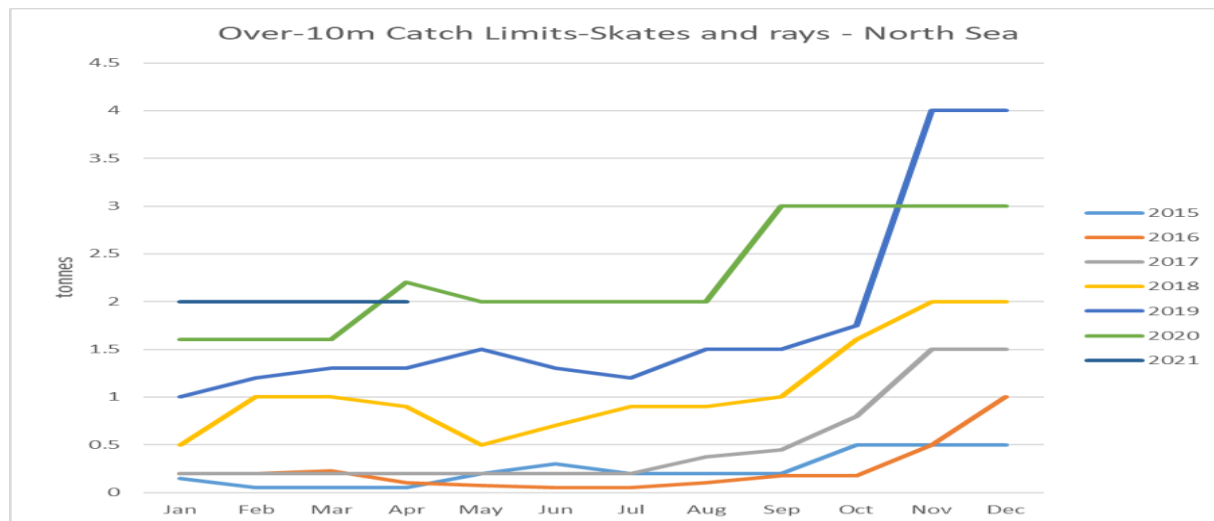
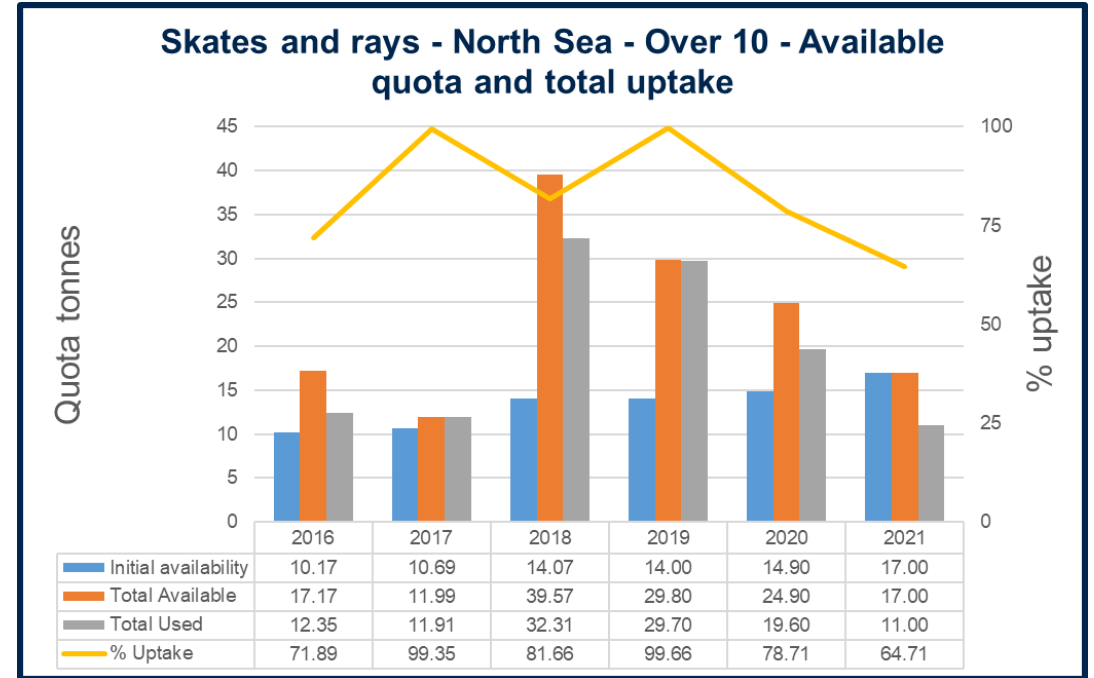
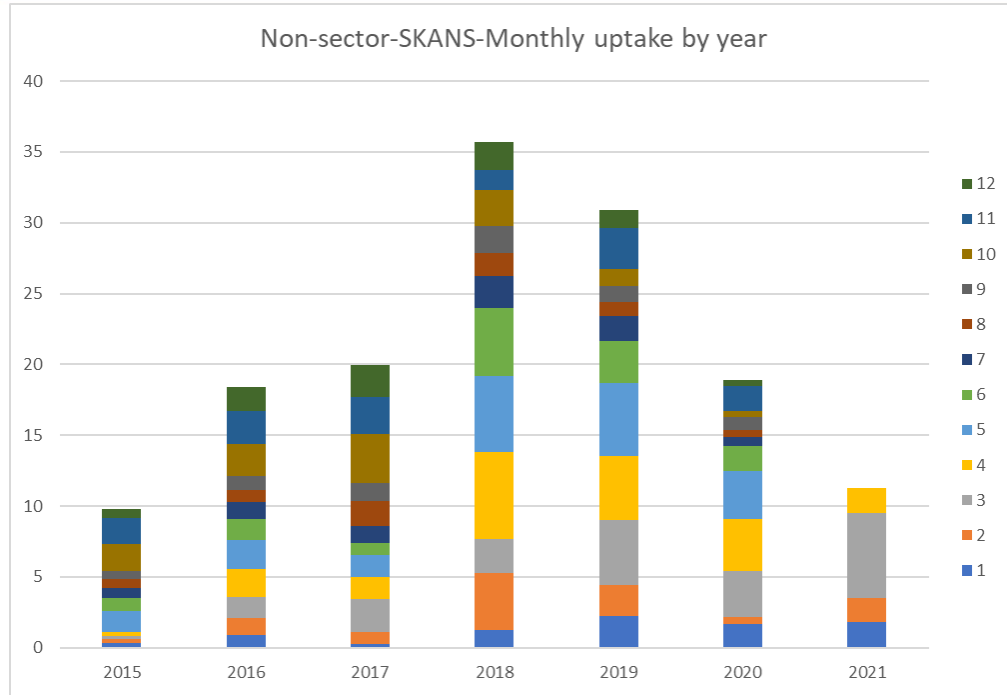
NS Skate & Rays – Under 10s

 2 boats nearing the catch limit

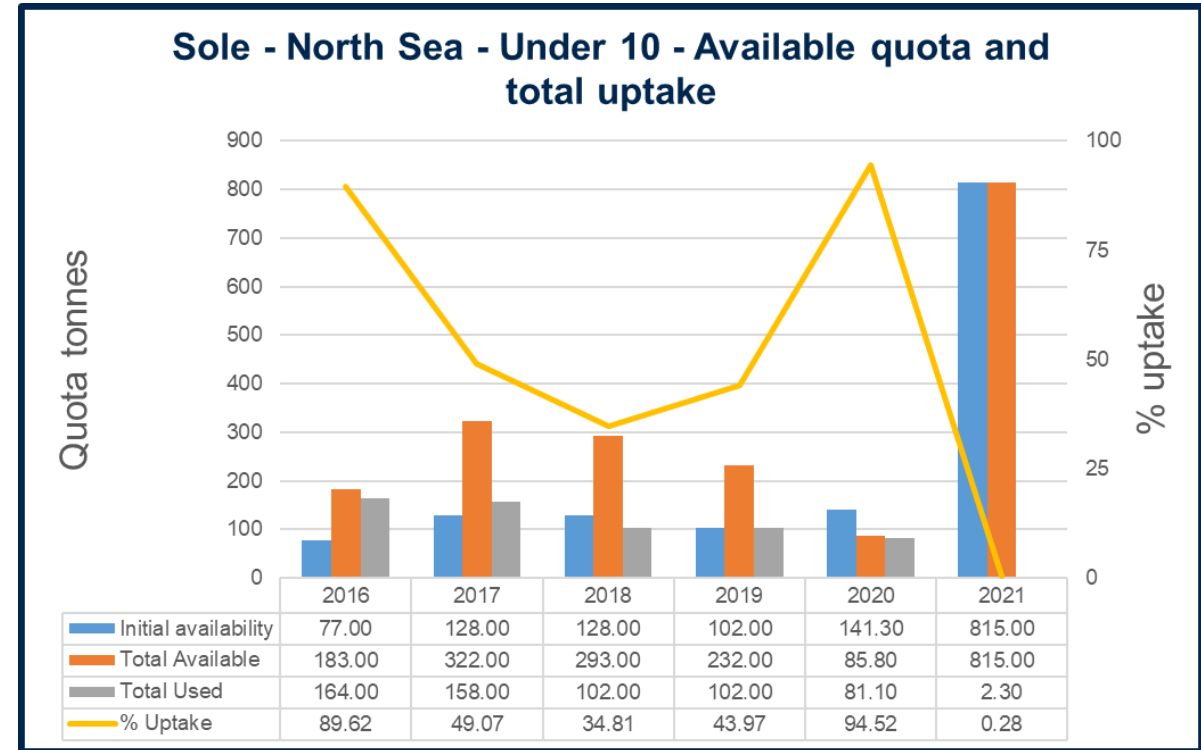
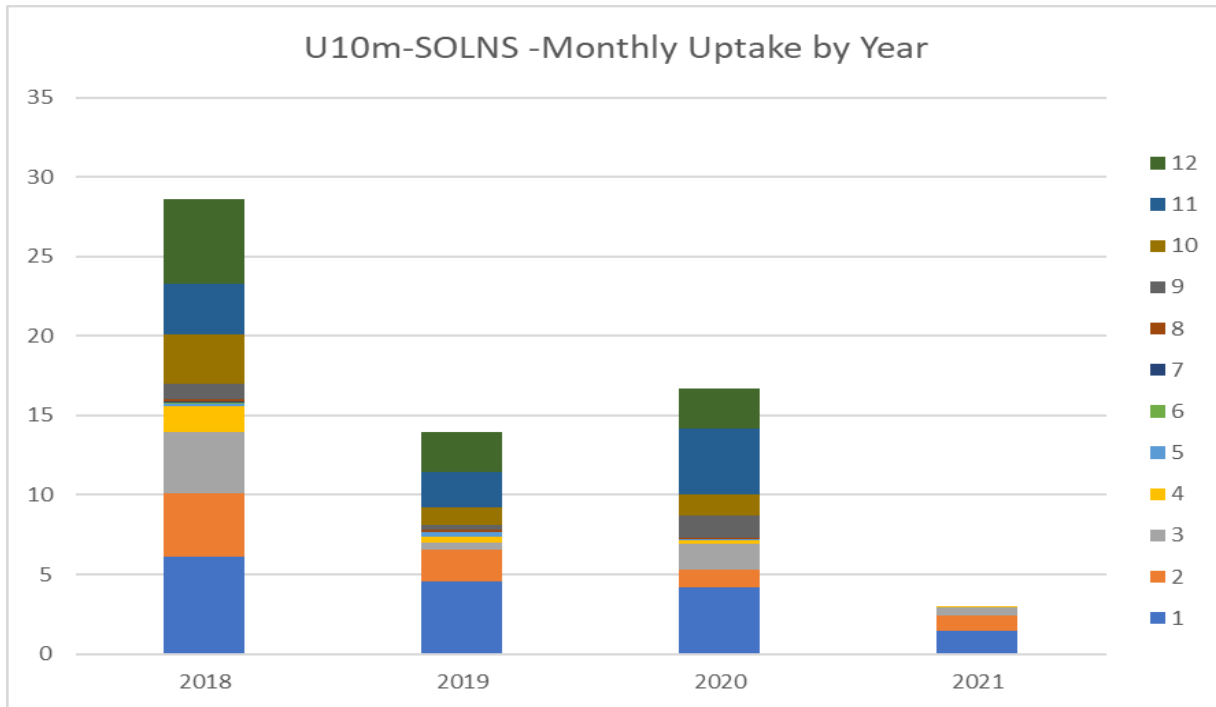
We have arranged trades for additional 45t and intend to agree more.

Uptake is significant compared to available quota but we anticipate trading more in to maintain landings.

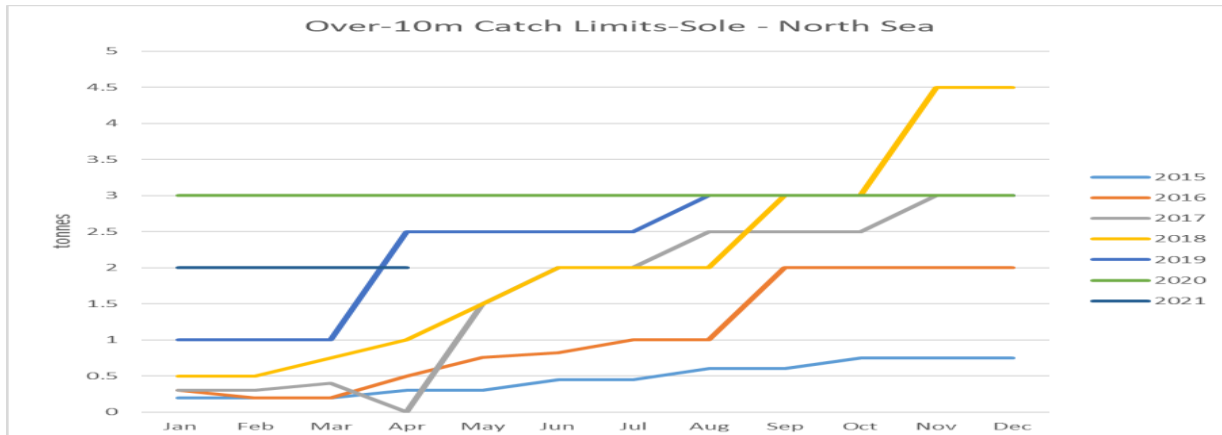
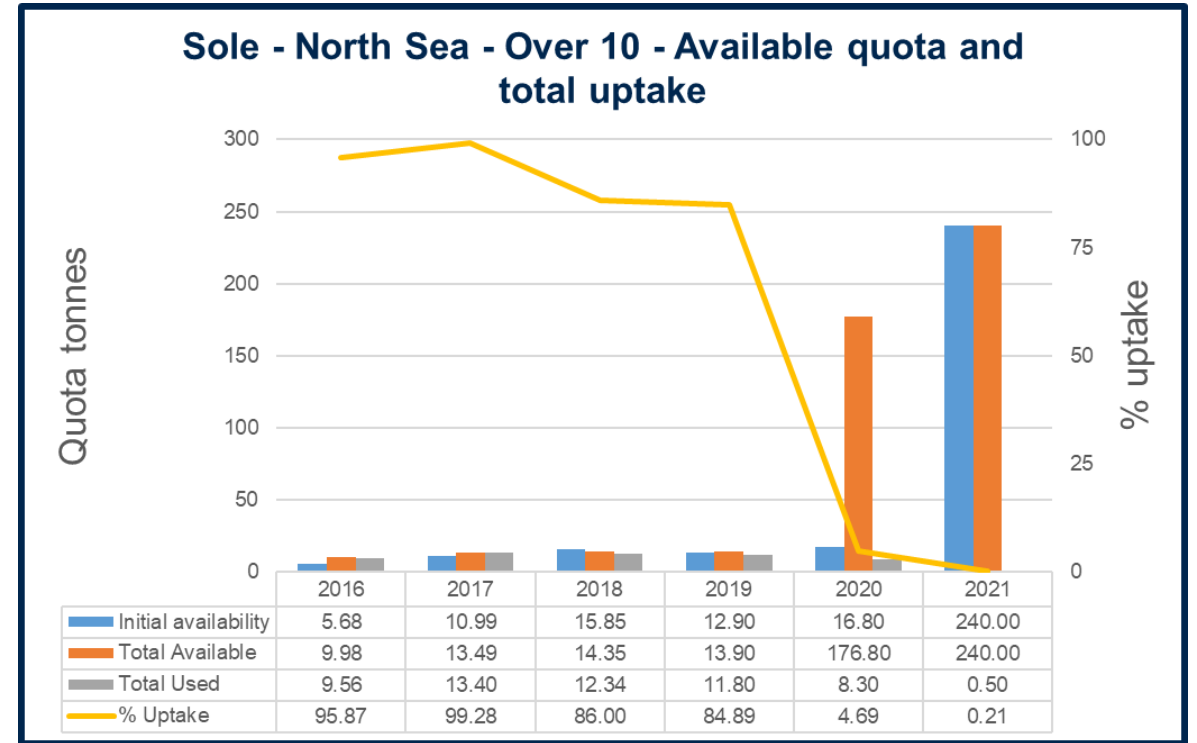
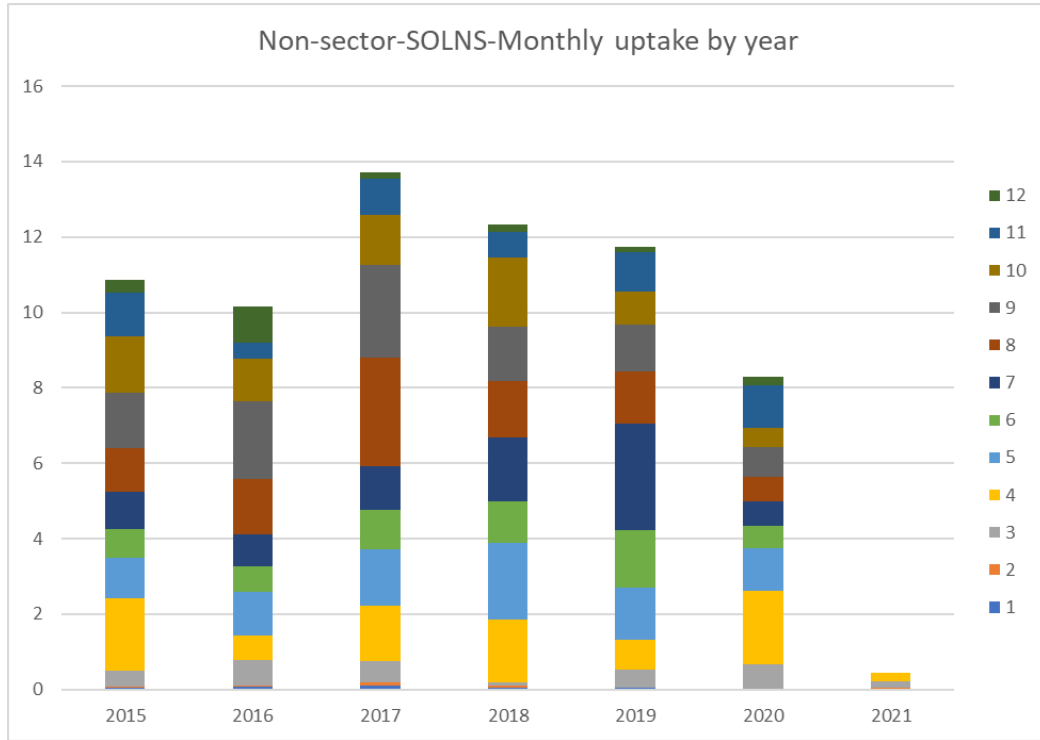
NS Sole – Under 10s

 No one catching the stock

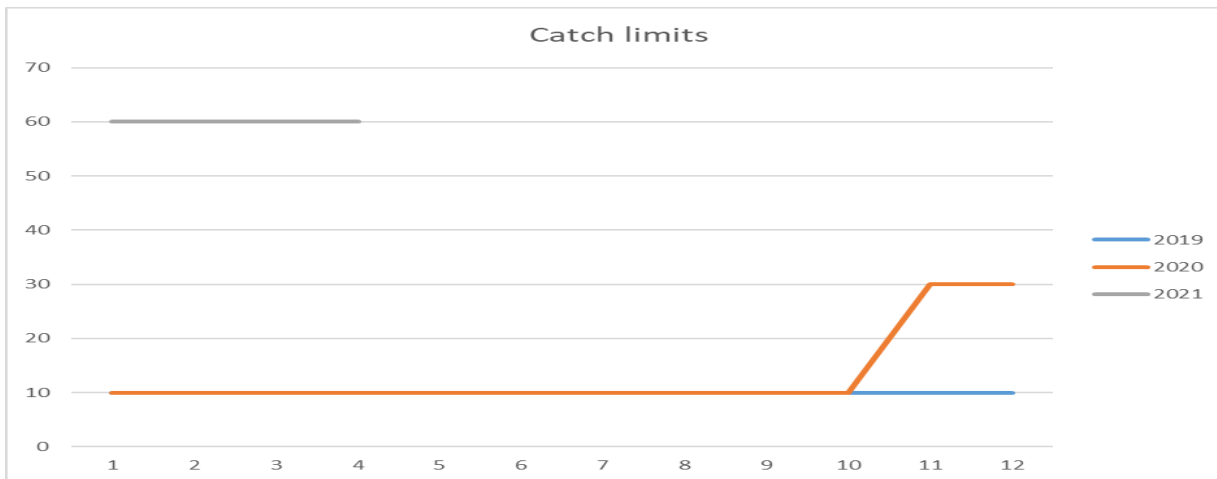
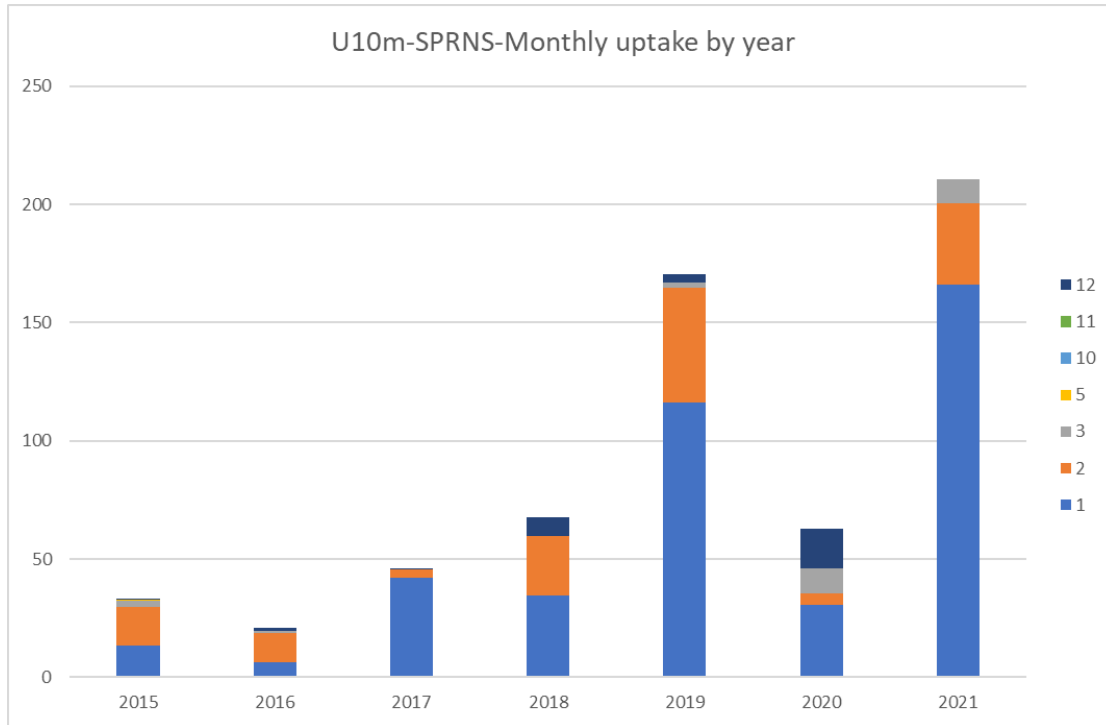
Significant amount of additional quota.
