- (d) the animals from which the meat was derived were examined ante-mortem and post mortem under the supervision of an Official Veterinarian.
 No clinical evidence of infectious or contagious disease was observed and the meat was found fit for human consumption;
- (e) the animals were slaughtered and the meat processed, cut and boned in approved establishments in accordance with hygiene legislation currently in force in the United Kingdom;

the meat and packages of meat referred to above bear a UK or GB health mark indicating that it has been obtained, handled and stored in accordance with UK hygiene regulations and continues to be wholesome and fit for human consumption;

(g) to the best of my knowledge and belief, the meat has been produced, handled, stored and transported within the United Kingdom in such a way as to prevent contact with any animal products not meeting the requirements of this certificate.

- (h) The animal products described above comply with the relevant United Kingdom animal health/public health standards and requirements;
