## **Introduction**

The following Standards relate to the construction of fishing vessels and include requirements for superstructure and machinery installations. Items other than those mentioned above are covered by the new CODE OF SAFE WORKING PRACTICE FOR THE CONSTRUCTION AND USE OF 15 METRE LENGTH OVERALL TO LESS THAN 24 METRE REGISTERED LENGTH FISHING VESSELS produced by the Maritime and Coastguard Agency (MCA). Recommendations for outfit are included in Parts 6 to 10 of these Standards.

The Standards will be reviewed by the Fishing Vessel Construction Standards Working Group at intervals not exceeding five years to take into account experience and any new statutory requirements that may be considered reasonable to apply to new vessels as applicable to these Standards.

Where new standards are developed and finalised by the Maritime and Coastguard Agency of the United Kingdom, Department for Transport (MCA), European Union (EU), the International Maritime Organisation (IMO), International Standards Organisation (ISO) or British Standards (BS) which impact upon the requirements of these Standards, amendment may be considered immediately and implemented by means of a Marine Information Note (MIN).

## **How you can contact us**

### **Plan Approval Process**

Before building a vessel, drawing approval is required for the vessel intended to be built. If you are building a one-off vessel an Application for Survey and Inspection of Ships and Fishing Vessels (form MSF 5100) and Additional Information (form MSF 1356) should be submitted to the Marine Office closest to where the vessel is to be built.
