IV. HEALTH CERTIFICATION

a) the meat was derived from animals which have passed ante-mortem and post-mortem inspection and found to be free from infectious and contagious diseases;

b) the meat has been inspected and found fit for human consumption and every precaution has been taken to prevent contamination prior to export;

c) they have been dressed, prepared and packed under hygienic conditions in accordance with regulations at present in force in the United Kingdom, and have been kept free from contamination prior to export;

d) in the case of meat/meat preparations/meat products of porcine origin, they were derived from animals slaughtered in the United Kingdom, which has been free from Foot and Mouth Disease (without vaccination), classical swine fever, African swine fever, swine vesicular disease and trichinellosis¹ for the last six months prior to the date of slaughter of the animals and the date of the export of the product to Singapore;

e) the meat was derived from animals which were slaughtered, processed, packed and stored under sanitary conditions under official veterinary supervision in the above-mentioned establishment approved by the Director General of the Singapore Food Agency (SFA) for export to Singapore;

f) the meat has not been treated with chemical preservatives or foreign substances injurious to health;

g) * **IN THE CASE OF PORK ONLY** the meat was derived from animals which have not been swill-fed;

h) * **IN THE CASE OF CHILLED PORK ONLY**

i) Chilled pork has been derived from entire males under 100kgs (dead weight) at time of slaughter, or gilts or castrates; and the products do not contain any harmful residues;

- ii) ***Either** Chilled pork must originate from animals raised in a compartment with negligible risk for *Trichinella* infection, in accordance with The World Organisation for Animal Health (WOAH) Article 8.18.5;
- *And/Or** Must come from animals that have tested negative for *Trichinella* larvae using an approved detection method;
- *And/Or** Must be processed in a manner that ensures the inactivation of *Trichinella* larvae, in line with the Codex Guidelines for the Control of *Trichinella* spp. in Meat of Suidae (CAC/GL 86-2015).
