

# **Objection to School Admission Arrangements for** academic year beginning in September 2023

If you consider that a school's admission arrangements are unlawful or do not comply with the School Admissions Code (<u>the Code</u>) and you wish to object to the Schools Adjudicator, please complete and return this form (preferably by email).

Objections can be made until 15 May 2022 for admission arrangements for 2023 academic year. All objections submitted by that deadline will be considered by an adjudicator provided the objection is within the adjudicator's jurisdiction. You should be aware that if your objection is within jurisdiction, a copy of this form will be sent to the school, the local authority and any religious body. The home addresses, email addresses and telephone numbers will be removed before forms are circulated where objectors are parents or members of the public.

If your concerns are about the admission arrangements for entry in a year other than the 2023 academic year or you wish to complain after 15 May 2022 about admission arrangements for 2023 you should still complete this form making clear to which year's admission arrangements you are referring. We will let you know whether or not we can consider your concerns.

Please note that the OSA does not have jurisdiction to deal with the allocation of school places for individual children or the application process followed by an admission authority. These are issues for the admissions team at your local authority.
