II.1 Public health attestation

II.2 Animal health attestation

I, the undersigned official veterinarian, hereby certify, that the fresh meat described in Part I:

- **II.2.1** has been obtained in the territory/ies with code ⁽³⁾ which, at the date of issuing this certificate:
