RE: Request for Information – RFI3906

Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

You requested the following information:

Full copies of all communications (including emails, letters and records of meetings) with Bristol City Council relating to Brislington Meadows dated 01/01/2022 through to 31/05/2022.

Where an email has been identified please disclose the full thread for context. Please also search draft and (where possible) deleted email folders.

Please also include any attachments.

Where a meeting has been identified please include the minutes, agendas and briefing materials along with any information handed out at the meetings.

Response

We can confirm that we do hold the information that you have requested. For clarity, of the communications mentioned in your request, Homes England only holds email correspondence (and attachments) that fall within scope.

Please find enclosed Annex A. Some of the information held has been redacted or withheld under the following exemptions:

Section 40 – Personal information

We have redacted information on the grounds that in constitutes third party personal data and therefore engages section 40(2) of the FOIA.

To disclose personal data, such as names, contact details, addresses, email addresses and personal opinions could lead to the identification of third parties and would breach one or more of the data protection principles.

Section 40 is an absolute exemption which means that we do not need to consider the public interest in disclosure. Once it is established that the information is personal data of a third party and release would breach one or more of the data protection principles, then the exemption is engaged. Section 41 – Information provided in confidence

Under section 41(1)(b) of the FOIA Homes England is not obliged to disclose information to the public if it would constitute a breach of confidence.

Links and passwords to online meetings which are held within correspondence and fall within scope of your request have been provided by a third party to Homes England in confidence with the expectation that they will not be publicly disclosed, and therefore section 41 of the FOIA is engaged. Release of this information would put the third party at risk of cyber-attack and fraud. Homes England have a duty to protect the financial interests of our partners. We would suffer reputational risk if potential future partners thought we would release confidential information.

Although section 41 of the FOIA is an absolute exemption and there is no requirement to conduct a full public interest test, we can confirm that we have considered the public interest as a breach of confidence may not be actionable if there is an overriding public interest in disclosure. We feel that there is no overriding public interest in favour of disclosure of this information.

Section 42 – Legal Professional Privilege

Under section 42(1) of the FOIA Homes England is not obliged to disclose information that constitutes advice given under legal professional privilege (LPP) which protects confidential communications between lawyers and clients which is a fundamental principle of English law.

Section 42 is a qualified exemption. This means that once we have decided that the exemption is engaged, Homes England must carry out a public interest test to assess whether it is in the wider public interest for the information to be disclosed.

Arguments in favour of disclosure:

 Homes England acknowledges there is a general public interest in promoting accountability, transparency, public understanding and involvement in how Homes England undertakes its work and how it spends public money.

Arguments in favour of withholding:

• Homes England believes that there is a strong argument to withhold the correspondence held in order to safeguard full and frank legal advice, which in turn is fundamental to the administration of justice.

Having considered the arguments for and against disclosure of the information, we have concluded that at this time, the balance of the public interest favours non-disclosure.

Section 43 - Commercial interests

Under section 43(2) Homes England is not obliged to disclose information that would, or would be likely to, prejudice the commercial interests of any party.

The information requested relates to ongoing discussions and appraisals of options to progress development at this site engages section 43(2) of the FOIA as it is commercial in nature and its release would be likely to prejudice the commercial interests of Homes England and other interested parties to the information.

Homes England has identified that the information requested, if released, would be likely to prejudice the effective operation of those parties' commercial activities.

Section 43 is a qualified exemption. This means that once we have decided that the exemption is engaged, Homes England must carry out a public interest test to assess whether or not it is in the wider public interest for the information to be disclosed.

Arguments in favour of disclosure:

- Homes England acknowledges there is a general public interest in promoting accountability, transparency, public understanding and involvement in how Homes England undertakes its work and how it spends public money; and
- Homes England acknowledges there is interest from the public in how we work with our partners in relation to progressing development.

Arguments in favour of withholding:

- The information relates to and directly affects ongoing commercial negotiations that Homes England and the third party are undertaking regarding future proposals at the site. If this information were released it would be likely to disadvantage Homes England's and the councils' commercial positions. The parties involved would not be able to negotiate effectively as this information could be used by other third parties to distort or otherwise prejudice the ability of the council to secure planning permission. This would not be in the public interest as it would put progress at risk and inflate prices. This would negatively affect public money and nullify work already undertaken;
- Some of the information is still subject to approval and options contained within not yet finalised. The
 consequences of releasing data that is part of wider ongoing proposals could damage our relationships with
 partners and put potential negotiations and planning at risk. This would not be in the public interest as this
 could put potential homes in jeopardy and would undermine Homes England's position and ability to deliver
 against its objectives and targets in our Strategic Plan;

- Releasing the information would be likely to negatively impact future development processes and proposals as interested parties may feel unable to provide all the relevant information necessary to Homes England for fear of disclosure. This would impact the ability of Government officials to make effective, informed decisions regarding allocation of public funds;
- Disclosing details of a third party's business proposals, processes and information not in the public domain may affect their relationship with other parties, including Homes England, and affect a party's reputation in the market. This would be likely to have a negative impact on the third party's ability to procure works or funding for ongoing development. Releasing information in relation to a third party in a competitive market would be likely to distort competition, making it a less competitive process. This would not be in the public interest as it would be likely to lead to third parties being unable to secure works for market value, or be successful in securing approvals for works and services. This would be likely to have a negative effect on future commercial activity. This would not be in the public interest as it would not activity. This would not be in the public interest as it would negatively affect Homes England's position as the government's housing accelerator and our ability to create successful and trusting relationships with partners; and
- Homes England has been unable to identify a wider public interest in disclosing the information requested.

Having considered the arguments for and against disclosure of the information, we have concluded that at this time, the balance of the public interest favours non-disclosure.

Thank you for your email and attachments which we shall review and comment on as necessary.

Re ""The schedule of tree removal is in the report along with the cumulative figures for canopy loss. Where groups are being removed our consultant has advised they would not typically provide the number of trees removed unless it were a group comprising clearly defined individual trees. With woodland or dense groups canopy cover is the appropriate measure for tree loss. A breakdown of expected tree removal by group and area can be provided if required but note that this is an outline application so these figures are based on conflict with the illustrative masterplan only".

Perhaps you could point out to the developer and their consultant that, for the Bristol Tree Replacement Standard (BTRS) to be properly applied, it is necessary to identify each individual tree being removed (whether or not in a group) together with its stem diameter and BS5837 Quality Category. The amount of canopy loss is irrelevant for the purposes of BTRS, though it may be relevant depending on how the habitat of trees, tree groups or woodlands is categorised under the Biodiversity Net Gain Metric - as one of the Woodland habitats or as an Urban Tree habitat or as one of the linear Hedgerow habitat. This is why we have asked for this information - a schedule of the trees, groups and woodlands where trees will be removed or partially removed together with the number of trees in each group or woodland to be removed plus the canopy areas being removed.

I also see that the applicant is 'not willing to share this format publicly given the nature and format of the document which can be edited'. Frankly, this is ridiculous. We have dealt with many other applications where the BNG calculation has been published on the planning portal - either in .xlsm or in .xlsx format - without any such objection being made.

Of course, a copy of any document published on the portal can be downloaded and altered - even those published as .pdfs (we do it all the time to extract base arboricultural and BNG data for our own calculations), but the advantage is that the 'original' is never changed because it is maintained by the LPA (as well as on the developer's servers) pristine and unchanged on the planning portal.

We fully intend to extract the habitat data used (yes, we can extract it from the .pdf, but the way it is formatted will make this very difficult and may result in errors) and decide what we accept and what we do not. If we consider it necessary, we will then publish the results of our own analysis (with our calculation if requested), but to imply that we would somehow ever seek to present any such 'edited' version as the applicant's goes beyond insulting.

As you know, when the Environment Act 2021 takes effect next year, developers will be obliged to disclose this evidence in any event. May we suggest that the LPA insist that Homes England do so now in this case.

You might also point out in passing that, should Homes England still refuse to disclose their BNG calculation, we shall submit an Fol request and obtain it that way.
