**RE: Request for Information – RFI3965**

Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

You requested the following information:

*Would you please provide me with a csv data export from your system. We are requesting all available anonymous data for applicants for both Northumberland county and the City of Newcastle upon Tyne please. Both areas are needed as although the sites in question are in Northumberland we believe there is likely to be strong interest from residents of Newcastle. Our aim is to understand the levels of demand generally across the two areas as well as more narrowly for the proposed developments in question.*

*It would be very helpful if you could answer some specific questions about the data to aid our interpretation of it.*

*Does the data include a date of registration field? If so, this would be helpful as we would like to consider the rate of flow of registrations as well as the absolute number. If not, do you have a date for the earliest registrations?*

*Is the database managed? If an applicant takes up an offer of affordable home ownership are they removed from the database?*

*To what extent is duplication a problem across the data bases for the two areas? Might an individual applicant be registered for both? In this event, would the database for Northumberland only suffice? Our understanding is that registrations for a specific scheme could come from anywhere in the country.*

*Finally, RSL Karbon Homes is likely to be the beneficiary of the proposed developments however our understanding is that it has declined our suggestion to enter into a service level agreement with Homes England to have direct access to the data.*

### Response

We can confirm that we do hold some of the requested information. We will address each of your questions in turn.

#### ***Would you please provide me with a csv data export from your system.***

Please see enclosed Annex A which contains the data export of anonymous data for applicants for both Northumberland County and the City of Newcastle upon Tyne.

#### ***Does the data include a date of registration field? If so, this would be helpful as we would like to consider the rate of flow of registrations as well as the absolute number. If not, do you have a date for the earliest registrations?***

We can confirm that the data set does include a date of registration field, identified as the 'Date Received' column contained within Annex A. We can advise that this is the date the applicant completed their application form.

#### ***Is the database managed? If an applicant takes up an offer of affordable home ownership are they removed from the database?***

We can confirm that the database is not managed as there is not mechanism in place to track applications that have resulted in completed transactions. Applicants are therefore not removed from the list when they complete a purchase.

#### ***To what extent is duplication a problem across the data bases for the two areas? Might an individual applicant be registered for both? In this event, would the database for Northumberland only suffice? Our understanding is that registrations for a specific scheme could come from anywhere in the country.***

We can confirm that duplication is not a problem across the databases for the two areas. When submitting an application, the system does not allow for the applicant to register in more than one region. However, if the applicant wanted to express an interest in more than one geographical area, we can advise that this would only be possible by submitting an application multiple, separate times. Given that the regional option selection does not place any restrictions on the applicant, there would not be any reason for them to apply repeatedly solely to change this field.

#### ***Finally, RSL Karbon Homes is likely to be the beneficiary of the proposed developments however our understanding is that it has declined our suggestion to enter into a service level agreement with Homes England to have direct access to the data***

We can confirm that only those providers who are receiving a grant from Homes England as part of the Shared Ownership Scheme are able to directly access data from the Help to Buy (HTB) Agent's website. These providers are required to sign a service level agreement set out by the HTB Agents before they are given access.

### Right to Appeal

If you are not happy with the information that has been provided or the way in which your request has been handled, you may request an internal review. You can request an internal review by writing to Homes England via the details below, quoting the reference number at the top of this letter.
