Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

How many new homes built in 2021 have rain water recovery and/or solar panels included as part of the build.

I am asking about ALL new homes built in 2021 that had rain water recovery and solar panels included in the build.

Response

We can confirm that Homes England does not hold the information detailed in your request. This is because there is no legal or business reason for Homes England to do so.

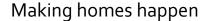
The FOIA does not oblige a public authority to create information to answer a request if the requested information is not held. The duty under section 1(1) is only to provide the recorded information held.

To comply with this duty we are able to confirm that Homes England are not involved directly in the construction of new homes, rather we provide funding to third parties (developers) and unlock land to partners, who then may go on to build homes with our support. We do not collect information from our partners as to rain water recovery/solar panels on homes built with Homes England assistance.

Right to Appeal

Your request for review must be made in writing, explain why you wish to appeal, and be received within 40 working days of the date of this response. Failure to meet this criteria may lead to your request being refused.

Upon receipt, your request for review will be passed to an independent party not involved in your original request. We aim to issue a response within 20 working days.

You may also complain to the Information Commissioner's Office (ICO) however, the Information Commissioner does usually expect the internal review procedure to be exhausted in the first instance.
