JUDGMENT OF THE EMPLOYMENT TRIBUNAL Rule 21 of the Employment Tribunal Rules of Procedure 2013

The Judgement of the Employment Tribunal under rule 21 of the Employment Tribunal (Constitution and Rules of Procedure) Regulations 2013 is that;

- the complaint under section 189 of the Trade Union and Labour Relations
 (Consolidation) Act 1992 (TULCRA) is well founded;
 - 2. the respondents are ordered to pay a protective award to the claimants in the attached schedule who were dismissed as redundant; the protective period begins on 28 April 2020, and is for a period of 90 days.

REASONS

The claimants in the attached schedule presented a claim under section 189
of TULCRA. No response was lodged to that claim, and the tribunal was
satisfied that it was appropriate to issue this judgement under Rule 21 of the
