### JUDGMENT

# Rule 21 of the Employment Tribunal Rules of Procedure 2013

The Employment Judge has decided to issue the following judgment on the available material under rule 21:

- 1 The claimants are entitled to bring this claim because none of the situations in s.189(1)(a), (b) or (c) of the Trade Union and Labour Relations (Consolidation) Act 1992 apply and the claimants were employees dismissed as redundant.
- 2 No response was presented to this claim within the applicable time limit.
- 3 The respondent is in liquidation being a creditor's voluntary liquidation.
- 4 The complaint that the respondent failed to comply with a requirement of section 188A of the Trade Union and Labour Relations (Consolidation) Act 1992 is well founded.
- 5 The respondent dismissed as redundant more than 20 employees at one establishment within a period of 90 days or less.

- 6 The respondent failed to ensure that employee representatives were elected in accordance with S.188A, and then to consult with them in accordance with s.188.
- 7 The Tribunal makes a protective award in respect of the claimants and the respondent is ordered to pay remuneration for the protected period. The protected period begins on 30 September 2020 having regard to s.189(4)(a) and is for 90 days.
