1. Welcome - Andy Carroll, Defra

Actions from previous meeting:

FaSS funding: Thanks to those here that raised the issue of trawler being exempt from the FaSS H&S funding. We've taken this away and can now confirm that FaSS have now enhanced and equalised the funding rates available to fund health and safety projects for the small-scale coastal fleet. This means that now *any* vessel with a length of 12 metres or less will be eligible for a funding rate of up to 80% for health and safety projects — regardless of the type of gear used. The MMO are in the process of updating guidance and their IT systems to reflect this change.

FMP meeting: We would like to remind everyone that Policy Lab will be in Barrow for a drop-in session to meet fishers and other stakeholders and discuss your experiences of bass fishing and regulation. Other updates:

- Skills and Training: Round One of the UK Seafood Fund Skills and Training scheme has opened for applications. You will be able to apply for a grant until the 12th October 2022. Further details can be found on the scheme's webpage. Round One is for improving or creating training courses or specialised training equipment. Round Two which we expect to open in the Autumn will be for constructing or modernising training centres. - Department for Trade Mental Health funding: Department for Transport have recently announced a support package for seafarers, including £2.4 million funding to support seafarers' mental wellbeing GOV.UK (www.gov.uk). The Merchant Navy Welfare Board, who are administering the £2.4m fund, welcomes grants that support fishers and have previously awarded funding in this area. The grant guidelines state that the MNWB 'supports the provision of quality welfare services for serving or retired seafarers'. This is also their mission statement and the wording seafarers is inclusive of fishers. Other updates:

Fuel prices: Number of people have asked about fuel. Like many sectors, the fishing industry is facing challenges as a result of global fuel prices. Though unlike many other sectors eligible vessels can utilise the Marine Voyages Relief which provides 100% relief on their fuel duty costs. Defra is continuing to engage with industry to discuss ongoing challenges and potential long-term mitigations, and we are working closely with Seafish, to refine their modelling to understand the potential impact on the fleet of fuel price increases. On top of the fuel duty relief the UK fishing sector receives, the UK Government has offered substantial funding to the fishing sector and continues to do so with funds like the £100 million UK Seafood Fund on top of schemes such as the FaSS (in England). FaSS provides extensive grant funding to fishing businesses, including through projects to enhance energy efficiency on vessels. For example, the scheme can fund investments to improve the hydrodynamics of the hulls of vessels or to reduce electricity or thermal energy consumption. Generous levels of funding have been made available to small fishing businesses — with up to 80% funding available to members of the small-scale coastal fleet and up to 60% for other micro-entities.

2. NW Initiative Update – Courtney Inch, MMO

Following feedback from this RFG, a consultant was hired on behalf of NFFO, Seafish and MMO to look at the region as a whole and conduct an 'industry feasibility' study. This came from concerns raised by industry in light of the significant decline in registered and licenced vessels and processors

in the NW and tries to pull in people from across the supply chain. Results have been distributed in draft, once the report is finalised it will be circulated to the RFG distribution list.

3. 2023 Quota Consultation - Ross Deadman, Defra

Question about the reference period for FQA's: this affects Fleetwood vessels who did not have a historical record of catching 7a stocks. Various EU countries have a large quota of Irish Sea stocks but no longer fish this area, is this going to be looked at.

Response from Defra: this consultation is only looking the current UK additional quota, but the TAC is due to be renegotiated with the EU in 2026 and this could be looked at then.

There is an historical issue linked to Fleetwood boats with FQAs attached to them being bought by flagged vessels and POs. This means uptake is low for various stocks in the Irish Sea, but these stocks are important to the inshore fleet and the quota could be allocated more effectively.

ACTION: take this to the Defra negotiations team.

4. Highly Protected Marine Areas, Allonby Bay - Jen Ashworth, Philip James, Defra



See slides for more details. Defra launched a consultation on 5 candidate sites on 6 July 2022. The Consultation closes **28th September**: Consultation on Highly Protected Marine Areas (HPMAs) - Defra - Citizen Space and questions please contact hpma@defra.gov.uk

- Defra want to gather additional social and economic evidence from stakeholders: there are gaps in the macro data used and Defra would like industries help to understand the level of fishing and recreational angling.
- The intention is that no fishing activity will be permitted in the site, including bait digging, dredging and other damaging activity.
- The views and evidence we gather will influence
 - Which sites are designated as HPMAs
 - Whether any boundaries for candidate sites should be changed
 - The assessment of the benefits versus the impacts

We will hold a series of online, site-based and national workshops, starting in late August, to
complement the consultation and gather further evidence. Within 12 weeks of the
consultation closing, we intend to publish a summary of responses. Pilot Highly Protected
Marine Areas will be designated within 1 year of the consultation, in line with s119(10) of
the Marine and Coastal Access Act 2009.

Candidate site overlaps with both Allonby Bay Marine Conservation Zone (MCZ), Solway Firth Special Protection Area (SPA), and part of Solway Firth Special Area of Conservation (SAC). Defra will be running a workshop in the Maryport at the end of September – details to be finalised and will be circulated.

5. Quota and Licencing Review - Katie James, MMO Lydia Osbourne, Defra

- Latent capacity: Temporary lift of the under-10m licence cap from 1 August 2022. The cap
 on some under-10m vessels which restricts their uptake to no more than 350kg per year of
 quota stocks will be temporarily lifted for the remainder of 2022. This is being done to
 facilitate uptake of available quota and as an exercise to make an initial test for any
 unexpected consequences of lifting the cap more permanently.
- Additional quota: The MMO were able to temporarily offer vessels with Cat B and Cat C licences additional quota: Offer of additional quota to vessels with Category B and C licences. Over 10m vessels with Category B or C licences have a limited number of quota stocks for which they can fish. Under this scheme, those vessels were able to apply for one-time offer of access to more opportunities for the remainder of 2022.

The temporary lifting of the cap is to trial any unintended consequences. Defra are
undertaking a general licencing review next year. If anyone has any suggestions or

Comment from DEFA: the temporary uncapping is welcome, but diversification is expensive, and many fishers will not diversify if the cap only lifted temporarily. The Isle of Mann fleet does not have access to the same grants as the English fleet.

Questions about how the fleet were made aware of the changes and how they track the quota they catch. The U10s received a licence variation in the usual way. They will be given the catch limits monthly, these are also available on the website:

Question: what is the time limit on the roll test for U15 m vessel?

This needs to be done every 5 years. Criteria is pass/fail based on time if roll period is less then the beam it will pass.
