Points discussed in relation to significant changes application(s).

Project: Whether to approve the age-range change at Thomas Rotherham College (Inspire Trust), Rotherham, to allow delivery of provision for young adults with an Education, Health, and Care Plan up to the age of 25, and to increase the capacity of the college from 1720 to 1733 to increase the size of the Flexible Learning Centre for young adults with SEND.

AB discussion:

Advisory Board members were not in attendance of this meeting, instead contributing their views by correspondence.

In June 2021, the Regional Schools Commissioner (now Regional Director) approved a proposal for Thomas Rotherham College to open a Flexible Learning Centre with a capacity of 20 places. This proposal seeks to expand the Flexible Learning Centre by 13 places

(increasing the overall capacity of the college from 1720 to 1733) and increase the age range to 16 to 25 to enable young adults to continue attending the centre.

Thomas Rotherham College was judged to be good in all areas following a full Ofsted inspection in October 2019, having previously been judged as requires improvement in January 2018.

Capital works are to be funded by the trust and local authority, with work to expand and improve the facilities beginning in July 2022. The places will be funded by the local authority.

A four-week consultation on the proposal was opened on Monday 27 June 2022 and closed on Monday 25 July 2022. No negative responses were received.

The Advisory Board members were in support of this proposal.

The financial health of the academy, the strength of financial management and governance in place at Inspire Trust and the impact on the trust's future financial health were also considered.
