

RE: Request for Information - RFI4023

Thank you for your recent email, which was processed under the Environmental Information Regulations 2004 (EIR).

You requested the following information in response to previous requests referenced RFI3886 and RFI3913:

the context of the original request RFI3886 and this subsequent RFI3913 related to information provided prior to and leading to funding award, whereas the information supplied, while helpful, appears to be subsequent to the funding award.

My understanding is that an expression of interest for the Forward Funding Award was registered on 28 September 2018, the Business Case was submitted on 7 December 2018 and the funding award was made on 25 February 2019, whereas Appendix A is dated 17th September 2019, approaching 7 months after funding award and the link provided was from January 2021.

We note from the response to request para b) that the applicant did not inform Homes England that for the level of funding requested the proposed relocation would have to be to a green belt site, despite the justifications in the business case set out in request RFI3886.

please advise what information and correspondence it received / issued leading to the funding award of £227m on 25 February 2019.

Response

We can confirm that we do hold the information requested.

Business Case Submission

Regarding your request for whether Homes England was informed by the applicant that the relocation in question would be to a green belt site, we can confirm that in your previous requests RFI3886 and RFI3913 it was interpreted that this information was sought post award of funding. Given that your most recent correspondence has clarified the scope (being prior to the award of funding) we can confirm that we do hold information in this scope.



Upon receipt, your request for reconsideration will be passed to an independent party not involved in your original request. We aim to issue a response within 20 working days.

You may also complain to the Information Commissioner's Office (ICO) however, the Information Commissioner does usually expect the internal review procedure to be exhausted in the first instance.
