

Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

You requested the following information:

We wish to make a freedom of information request concerning a Grant provided to Gateshead Council in June 2007 for the restoration of St Mary's Church Oakwellgate, Gateshead, Tyne & Wear.

Specifically, we would like to request copies of the following documents:-

- 1. Single Programme / ONE (now Homes England) Grant Application form completed by Gateshead Council seeking a Grant for the restoration of St Mary's Church
- 2. Single Programme / ONE (now Homes England) Grant Agreement entered into by Gateshead Council for a Grant of £900,000 for the restoration of St Mary's Church in 2007

Response

We can confirm that Homes England does not hold the information detailed in your request.

To conclude that the information is not held, we have searched with our Grants team who would have the requested information if held.

The FOIA does not oblige a public authority to create information to answer a request if the requested information is not held. The duty under section 1(1) is only to provide the recorded information held.

Your request for review must be made in writing, explain why you wish to appeal, and be received within 40 working days of the date of this response. Failure to meet this criteria may lead to your request being refused.

Upon receipt, your request for review will be passed to an independent party not involved in your original request. We aim to issue a response within 20 working days.

You may also complain to the Information Commissioner's Office (ICO) however, the Information Commissioner does usually expect the internal review procedure to be exhausted in the first instance.
