### **PROVISION OF REQUESTED INFORMATION**

Thank you for your request for information about dog imports, which APHA received on 16 June 2022. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and the response is detailed below:

"In relation to the current ban on dogs coming into the UK from specified countries, please provide the following information.

1. How many dogs entered the UK from those countries in the last 5 years?

Pet dogs (non-commercial) travel on the pet travel scheme, The data regarding the Pet Travel Scheme covers pets entering Great Britain and is based on information provided by checkers employed by approved carriers of pet animals they do not record the country of origin .

2. Of this number, how many were found to have rabies, as a total number and a percentage of the total number?

4. For people coming to UK from Ukraine, how many were registered as bringing dogs/other pets with them? As a number, and as a percentage of those entering the UK.

APHA do not hold information on the number of people entering the UK from Ukraine. APHA can confirm we have received 2,144 applications for pets entering GB from Ukraine.

5. Details of those bodies involved in determining that a ban was necessary including details of any meetings, redacted as necessary, which do not fall within Section 35 of the FOI Act."

UK Government Ministers made the decision to implement a temporary suspension on the importation of commercial dog movements from Ukraine, Belarus, Poland and Romania taking into account advice from Defra's Animal Disease Policy Group (ADPG). The ADPG provides the UK wide policy forum where disease control policy, and sanitary and phytosanitary system (SPS) and strategic recommendations should be presented, reviewed, discussed, challenged and agreed. Collective views reached are put to respective sets of Ministers for agreement. ADPG also has an important role in making sure policies are, as far as possible, consistent across the 4 administrations. ADPG membership includes the 4 CVOs from across the UK and other representatives from the four administrations, and public health bodies who provide advice on zoonotic disease.

ADPG meetings at which the temporary suspension on the importation of commercial dog movements from Ukraine, Belarus, Poland and Romania was discussed took place on the following dates:

- 28 March 2022
- 7 April 2022
- 28 April 2022
- 12 May 2022
- 26 May 2022
