### **General discussion points**

#### **RD** update

• RD welcomed the new Advisory Board (AB)

#### Induction

- RD provided an overview of the core functions of Regions Group (RG), role of AB and introduced the RG London team.
- Discussed regional picture in London, which included academisation and Ofsted judgments.

#### **AB** discussion

- Question on how schools are identified for intervention.
- AB discussed Ofsted complaints.

#### **Converter academy orders**

Points discussed in relation to school conversion.

**Project**: Downshall Primary School, Redbridge – to convert to become an academy and join New Vision Trust (NVT) in Newham

**AB discussion**: Downshall Primary School is a 2FE school in Redbridge wanting to join a trust in Newham

Downshall has been working with NVT for many years. They are in close proximity.

The trust has English and maths hubs and a good CPD offer.

Discussed consultation which took place in February and over the summer. No major concerns identified.

Discussed trust finances and governance compliance.

Noted falling pupil numbers at school.

**RD decision**: Approve

**Project**: Ernest Bevin College (EBC), Wandsworth – to convert to become an academy and join United Learning Trust (ULT)

**AB discussion**: EBC, a boys secondary selective school, is seeking to join ULT to improve the students and college community.

EBC was judged to be good by Ofsted in June 2022, following a requires improvement judgement in December 2018.

Governing body supports EBC joining ULT as due to the trust's extensive experience of school improvement.

Noted falling pupil numbers and recruitment and retainment challenges.

**Project**: Downe Primary, Bromley – to convert to become an academy and join the Pioneer Academy (TPA)

**AB discussion**: Downe Primary School is a small rural primary school with 74 pupils on roll in 2021/22. It was last inspected by Ofsted in 2017 and was judged to be good.

The proposal is supported by the governing body and the London Borough of Bromley.

TPA are currently supporting Downe Primary School under a Memorandum of Understanding with the London Borough of Bromley.

No major issues identified following consultation.

A trust wide improvement plan, submitted by TPA, included Downe Primary as a part of a 3year plan for strategic capital investment along with other school improvement areas of focus.

## **Sponsor application**

Points discussed in relation to a school's sponsor application.

**Project**: Wandle Learning Trust, Wandsworth – sponsor application

**AB discussion**: Wandle Learning Trust is a Wandsworth based Multi Academy Trust, which currently comprises of four schools (3 primary schools and 1 secondary school in Wandsworth and Croydon).

Wandle Learning Trust has a strong track record of school-to-school support and is a nationally accredited Maths, English and Teaching School Hub.

AB noted that the trust currently operates on a joint CEO model.

## Significant change

Points discussed in relation to significant changes application(s).

**Project:** Marshalls Park Academy, Havering – sixth form expansion

**AB discussion:** Marshalls Park Academy in Havering is a 11-16 secondary school which is part of South West Essex Community Schools Trust (SWECET). The trust has applied to add a sixth form at the school.

Although students and parents want to see more school-based sixth forms in Havering, there is not a clear need for additional sixth form places at this time.

Positive consultation – no significant concerns raised.

The LA are generally supportive but noted the lack of need for additional post-16 places.

AB discussed parental choice, local opportunities already available and how new provisions would affect existing providers.

Project: Abbs Cross Academy and Arts College, Havering - sixth form expansion
