# Part II. Certification

### II.1 Public health attestation

I, the official veterinarian, declare that I am aware of the relevant provisions of Regulations (EC) Nos 178/2002, 852/2004, 853/2004, 2019/624 and 2019/627 and hereby certify that the wild game-bird meat <sup>(1)</sup> described in this certificate has been obtained in accordance with those requirements, and in particular that:

- (a) it is from (an) establishments(s) implementing a programme based on the HACCP Principals in accordance with (EC) No 852/2004;
- (b) it has been produced in compliance with the conditions set out in Section IV of Annex 3 to Regulation (EC) No 853/2004;
- (c) it has been found fit for human consumption following post-mortem carried out in accordance with Section 3 to Regulation(EU) No 2019/627;
- (d) it has been marked with an identification mark in accordance with Section I of Annex 2 to Regulation (EC) No 853/2004;
- (e) the guarantees covering live animals and products thereof provided by the residue plans submitted in accordance with Directive 96/23/ EC, and in particular Article 29 thereof, are fulfilled.

#### **II.2** Animal health attestation

I, the undersigned official veterinarian, hereby certify that the wild game-bird meat described in this certificate:

**II.2.1** (a) was obtained from wild game-birds that were killed in
