### II.1 Public health attestation

I, the undersigned, official veterinarian, declare that I am aware of the relevant provisions of Regulations (EC) No 178/2002, (EC) No 852/2004, (EC) No 853/2004 and (EU) 2017/625 and hereby certify that the meat of wild land mammals other than *ungulates* and *leporidae* <sup>(1)</sup> described in this certificate has been obtained in accordance with those requirements and, in particular that:

- (a) it comes from (an) establishment(s) implementing a programme based on the HACCP principles in accordance with Regulation (EC) No 852/2004;
- (b) it has been obtained in compliance with Section IV of Annex III to Regulation (EC) No 853/2004;
- <sup>(2)</sup>[(c) it fulfils the requirements of Commission Regulation (EC) No 2015/1375 laying down specific rules on official controls for *Trichinella* in meat, and in particular has been subjected to an examination by a digestion method with negative results];
- (d) it has been found fit for human consumption following post-mortem inspections carried out in accordance with Section 3 to Regulation (EU) 2019/627;
- (e) the carcass or parts of the carcass of large wild mammals have been marked with a health mark in accordance with Article 48 and Annex II to Regulation (EU) 2019/627;

- (h) it has been stored and transported in accordance with the relevant requirements of Section IV of Annex III to Regulation (EC) No 853/2004;

**II.2 Animal health attestation**

I, the undersigned official veterinarian, hereby certify that the meat of wild land mammals other than *ungulates* and *leporidae* <sup>(1)</sup> described in this certificate:
