# Project: Discussion to consider Sandbrook Community Primary School, Rochdale, to convert and join Watergrove Trust.

#### AB discussion:

- The board agreed this proposal worked well geographically and would create a strong cluster of schools within the area.
- The board agreed to the following conditions:
  - SRMA to be deployed to at trust level.
  - Trust to review governance board to ensure there is sufficient expertise across all areas.
  - External review of governance.
  - Trust to provide overview of the co-ordination of and accountability for school improvement across the trust

# Project: Discussion to consider Gayton Primary School, Wirral, to convert and join Cheshire Academies Trust.

#### AB discussion:

- The Board agreed that as the trust grows, they will need to review School Improvement plan and create a more robust strategy which does not rely on peer review. This will also support the trust with future growth plans in the event they take on more challenging schools.
- The board also suggested that the trust should develop their strategic brand within the Cheshire sub-region and consider how they will support other schools within the nearby area.

#### AB discussion:

- SFSO informed the board that an SRMA has been planned for both trusts to understand where efficiencies can be made.
- West Lakes MAT will need to continue working with SFSO and provide a financial plan on how the trust will manage any financial risks.
- The board also suggested that West Lake MAT should reflect on their trust board composition and consider how this will merge with QEGS.
- The board have also sought clarity on West Lake's scheme of delegation and how QEGS fits within this.
