Part II. Declaration

I, the undersigned, declare that the untreated wool ⁽¹⁾ and/or hair ⁽¹⁾ is produced from animals other than those of the porcine species:

- (a) at least 21 days before the date of entry into Great Britain;
- (b) in a third country or region thereof as listed in a document relating to 'fresh meat of ungulates' published on gov.uk, in accordance with Regulation (EU) No 206/2010⁽²⁾ and authorised for imports into Great Britain, Channel Islands or Isle of Man of fresh meat of ruminants not subject to supplementary guarantees A and F mentioned therein; and
- (c) from animals kept in the third country or region thereof referred to in point (b) free of foot-and-mouth disease and, in the case of wool and hair from sheep and goats, of sheep pox and goat pox in accordance with the basic general criteria listed in Annex II to Directive 2004/68/EC.

Notes

References to European Union legislation within this certificate are references to direct EU legislation which has been retained in Great Britain (retained EU law as defined in the European Union (Withdrawal) Act 2018) and can be viewed on the UK legislation website (legislation.gov.uk).

References to Great Britain in this certificate include Channel Islands and Isle of Man.
