- (c) from animals kept in the third country or region thereof referred to in point (b) free of foot-andmouth disease and, in the case of wool and hair from sheep and goats, of sheep pox and goat pox in accordance with the basic general criteria listed in Annex II to Directive 2004/68/EC.
