

Criminal Legal Aid Review: fee uplift scenarios guidance

The crime fee increases introduced from 30 September 2022 applied to a wide range of criminal legal aid schemes. The increases will also now apply to

- (a) existing cases with representation orders granted between 17 September 2020 and 29 September 2022 **and** where the main hearing takes place on or after 31 October 2022, and
- (b) existing cases with representation orders granted between 1 April 2016 and 16 September 2020 (LGFS) or 31 December 2018 and 16 September 2020 (AGFS) **and** where the main hearing takes place on or after 23 December 2022, where fees fall to be determined under Schedule 1 to the Remuneration Regulations, Schedule 2 to those Regulations, or both.

Details of the revised fees and hourly rates are set out in the Criminal Legal Aid (Remuneration) (Amendment) Regulations 2022. The changes which apply the uplifted fees to cases with a main hearing after 31 October 2022 are set out in the Criminal Legal Aid (Remuneration) (Amendment) (Amendment) (No.2) Regulations 2022. The changes which apply the uplifted fees to cases with a main hearing after 23 December 2020 are set out in the Criminal Legal Aid (Remuneration) (Amendment) (No.2) Regulations 2022. This table exists to provide guidance as to the applicable fee in certain scenarios where the uplifted graduated fee which came into force from 30 September 2022 may apply to pre-30 September 2022 ongoing cases.

Uplifts to cases with representation orders granted between 1 April 2016 and 16 September 2020 (LGFS) or 31 December 2018 and 16 September 2020 (AGFS) **and** where the main hearing takes place on or after 23 December 2022 will only apply to the graduated fee elements in place under the fee schemes governing these cases and will not include the CLAR accelerated measures introduced in September 2020.
